1 2 3 4 5	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in snowmobiles and all-terrain vehicles, further providing for registration of snowmobile or ATV, for certificate of title for snowmobile or ATV, for fees and for records; and providing for vintage snowmobile permits.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. The definition of "snowmobile" in section 7702 of
9	Title 75 of the Pennsylvania Consolidated Statutes is amended
10	and the section is amended by adding definitions to read:

12	The following words and phrases when used in this chapter
13	shall have, unless the context clearly indicates otherwise, the
14	meanings given to them in this section:

16	"Snowmobile." An engine-driven vehicle which is all of the
17	following:

1	(1) Is designed to travel over snow or ice.
2	(2) Has an endless belt track or tracks.
3	(3) Is steered by a ski or skis.
4	(4) Has an overall width of 48 inches or less.
5	The term does not include a farm tractor, construction
6	equipment, military vehicle, vehicle with inflatable tires or
7	machinery used strictly for the grooming of snowmobile trails.
8	The term includes vintage snowmobiles.
9	* * *
10	"Vintage snowmobile." A snowmobile that is at least 25 years
11	old and is not operated in this Commonwealth except at vintage
12	snowmobile events.
13	"Vintage snowmobile event." A ride or rally intended for the
14	participation by vintage snowmobiles on a designated trail, on a
15	specific date and with a specified beginning and end point. AN
16	ORGANIZED RIDE OR RALLY FOR OWNERS AND OPERATORS OF VINTAGE
17	SNOWMOBILES, FOR WHICH A PERMIT HAS BEEN ISSUED UNDER SECTION
18	7718(A) (RELATING TO VINTAGE SNOWMOBILE PERMITS) AND CARRIED AND
19	EXHIBITED IN COMPLIANCE WITH SECTION 7718(B) AND WHICH MEETS ALL
20	OF THE FOLLOWING CONDITIONS:
21	(1) IT IS OPEN TO THE PUBLIC AND PUBLICIZED AS SUCH.

- 11 (a) Issuance of permits.--Upon receipt of an application
- 12 upon a form prescribed and furnished by the department which

13 shall contain information required by the department and which

14 shall be accompanied by the required fee and any other

15 information the department shall require, the department shall

16 issue to an owner of a vintage snowmobile a vintage snowmobile

17 permit containing a permit number.

18 (b) Carrying and exhibiting permit. -- Every permit shall, at

19 all times while the vehicle is being operated, be in the

20 possession of the person driving or in control of the vehicle or

21 carried in the vehicle and shall be exhibited on demand of a

22 police officer or authorized department employee.

23 (c) Not transferable. -- A vintage snowmobile permit is not

24 transferable to a successor owner or to another vehicle. On

25 transfer of ownership of a vintage snowmobile for which a

26 vintage snowmobile permit has been issued, the permit shall

27 <u>become invalid.</u>

28 (d) Suspension or revocation. -- The department may suspend or
 29 revoke a vintage snowmobile permit upon conviction of the holder
 30 of an offense under this chapter. A suspended or revoked vintage

- 1 <u>snowmobile permit is invalid.</u>
- 2 Section 7. This act shall take effect in 30 days.
