AN ACT

Amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, in lobbying disclosure, further providing for prohibited activities and for penalties. 3 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Sections 13A07(f)(2) and 13A09(c)(1) and (e) of 6 7 Title 65 of the Pennsylvania Consolidated Statutes are amended 8 to read: § 13A07. Prohibited activities. * * * 10 11 (f) Unlawful acts.--12 13 The commission may receive complaints regarding 14 violations of this subsection. If the commission determines a 15 violation of this subsection has occurred, the commission, 16 after investigation, notice and hearing: 17 shall impose an administrative penalty in an

amount not to exceed [\$2,000] \$10,000; and

- 6 (c) Negligent failure to register or report. --
- 7 (1) Negligent failure to register or report as required
- 8 by this chapter is punishable by an administrative penalty
- 9 not exceeding [\$50] <u>\$250</u> for each late day.

- 12 (1) A person that intentionally fails to register or
- 13 report as required by this chapter commits a misdemeanor of
- the [second] <u>first</u> degree.
