A JOINT RESOLUTION

- Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, reducing the size of the General Assembly.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- A hereby resolves as follows:
- 5 Section 1. The following amendment to the Constitution of
- 6 Pennsylvania is proposed in accordance with Article XI:
- 7 That section 16 of Article II be amended to read:
- 8 § 16. Legislative districts.
- 9 The Commonwealth shall be divided into 50 senatorial and
- 10 [203] 153 representative districts, which shall be composed of
- 11 compact and contiguous territory as nearly equal in population
- 12 as practicable. Each senatorial district shall elect one
- 13 Senator, and each representative district one Representative.

- 1 Unless absolutely necessary no county, city, incorporated town,
- 2 borough, township or ward shall be divided in forming either a
- 3 senatorial or representative district.
- 4 Section 2. (a) Upon the first passage by the General
- 5 Assembly of this proposed constitutional amendment, the
- 6 Secretary of the Commonwealth shall proceed immediately to
- 7 comply with the advertising requirements of section 1 of Article
- 8 XI of the Constitution of Pennsylvania and shall transmit the
- 9 required advertisements to two newspapers in every county in
- 10 which such newspapers are published in sufficient time after
- 11 passage of this proposed constitutional amendment.
- 12 (b) Upon the second passage by the General Assembly of this
- 13 proposed constitutional amendment, the Secretary of the
- 14 Commonwealth shall proceed immediately to comply with the
- 15 advertising requirements of section 1 of Article XI of the
- 16 Constitution of Pennsylvania and shall transmit the required
- 17 advertisements to two newspapers in every county in which such
- 18 newspapers are published in sufficient time after passage of
- 19 this proposed constitutional amendment. The Secretary of the
- 20 Commonwealth shall submit this proposed constitutional amendment
- 21 to the qualified electors of this Commonwealth at the first
- 22 primary, general or municipal election which meets the
- 23 requirements of and is in conformance with section 1 of Article
- 24 XI of the Constitution of Pennsylvania and which occurs at least
- 25 three months after the proposed constitutional amendment is
- 26 passed by the General Assembly.
- 27 Section 3. Upon ratification by the electors, the General
- 28 Assembly shall enact legislation to implement this
- 29 constitutional amendment so that it applies for the first time
- 30 to the first session of the General Assembly which begins after

1 the 2020 reapportionment.
