AN ACT

- Amending the act of November 22, 1978 (P.L.1166, No.274), entitled "An act establishing the Pennsylvania Commission on 2 Crime and Delinquency, providing for its powers and duties 3 establishing several advisory committees within the commission and providing for their powers and duties," 5 providing for a task force on drug-endangered children. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. The act of November 22, 1978 (P.L.1166, No.274), 10 referred to as the Pennsylvania Commission on Crime and 11 Delinquency Law, is amended by adding a section to read: 12 Section 7.3. Task Force on Drug-Endangered Children. 1.3 (a) Establishment. -- There is hereby established within the 14 Pennsylvania Commission on Crime and Delinquency a task force on 15 drug-endangered children. (b) Composition. -- The task force shall be comprised of the

| 30 | (c) Objectives The overall goal of the task force is to |

- 1 improve the health of children exposed to chemicals associated
- 2 <u>with methamphetamine production or other drug involvement by</u>
- 3 identifying the physical, psychological and sociological effects
- 4 on children and providing appropriate intervention. The task
- 5 <u>force shall develop protocols establishing a Statewide response</u>
- 6 system and a strategic plan related to helping children who may
- 7 <u>have been endangered by circumstances involving the illegal</u>
- 8 production of methamphetamine or other drugs or by trafficking
- 9 or abuse. The task force shall meet the following objectives:
- 10 (1) The establishment of medical protocols for the
- treatment of children who have been endangered by
- 12 <u>contamination from methamphetamine manufacturing or other</u>
- exposure to drug production, trafficking or abuse.
- 14 (2) The development of coordinated procedures by
- agencies that quickly respond to the needs of children who
- 16 <u>have been exposed to the contaminants of illegal drug</u>
- 17 production to ensure their protection and safety.
- 18 (3) The elimination of any delays in the response that
- 19 would interfere with important child welfare outcomes aimed
- 20 at ensuring child protection and safety.
- 21 (4) The development of protocols for the sharing of
- 22 information among the various affected response agencies.
- 23 (5) The assurance that all affected children will
- 24 continue to be enrolled in school programs.
- 25 (d) Report.--The task force shall prepare a report
- 26 containing the strategic plan for the Statewide response system
- 27 and the strategic plan for the treatment of children who have
- 28 been endangered by contamination from methamphetamine
- 29 manufacturing, drug production, trafficking or abuse. This
- 30 report will serve as a blueprint for the development of

- 1 formalized training and education activities by the commission.
- 2 This report shall be submitted to the General Assembly within
- 3 one year after the effective date of this section and
- 4 <u>distributed to those State and local agencies that respond to</u>
- 5 <u>drug-endangered children.</u>
- 6 (e) Training. -- The commission shall develop training and
- 7 <u>education programs that will be available to those agencies that</u>
- 8 respond to drug-endangered children. The training shall reflect
- 9 the task force's plan to ensure that State and local agencies
- 10 are able to establish the necessary protocols for a coordinated
- 11 <u>response to drug-endangered children.</u>
- (f) Expiration. -- The provisions of subsections (a), (b), (c)
- 13 and (d) shall expire one year after the effective date of this
- 14 section. The commission shall continue to provide training and
- 15 education activities and act as a clearinghouse for information
- 16 <u>in relation to its duties under this section on an ongoing</u>
- 17 basis.
- 18 Section 2. This act shall take effect in 60 days.
