AN ACT

- Establishing an emergency medical services memorial flag; and imposing duties on the Pennsylvania Emergency Health Services
- 3 Council and the Bureau of Emergency Medical Services in the
- 4 Department of Health.
- 5 WHEREAS, The provision of an emergency medical services
- 6 memorial flag is a small but important act by Commonwealth
- 7 government to signify its thanks and recognition for the
- 8 sacrifice of a life in service to the citizens of this
- 9 Commonwealth; and
- 10 WHEREAS, The General Assembly enacts this legislation on
- 11 behalf of all Commonwealth citizens to honor emergency medical
- 12 services personnel who have died in the line of duty.
- 13 The General Assembly of the Commonwealth of Pennsylvania
- 14 hereby enacts as follows:
- 15 Section 1. Emergency medical services memorial flag.

- 1 (a) Establishment. -- An emergency medical services memorial
- 2 flag is established for this Commonwealth.
- 3 (b) Description. -- The flag established in subsection (a)
- 4 shall be created by the Bureau of Emergency Medical Services in
- 5 the Department of Health in cooperation with the Pennsylvania
- 6 Emergency Health Services Council.
- 7 Section 2. Use of flag.
- 8 The emergency medical services memorial flag may be displayed
- 9 over emergency medical service memorials, emergency medical
- 10 service funeral processions and from the poles of any public
- 11 ground or political subdivision for a period of not more than
- 12 seven days after the death of a member of any emergency medical
- 13 service, and as further directed by the Director of Emergency
- 14 Medical Services in the Department of Health.
- 15 Section 3. Agency responsibility.
- 16 The Bureau of Emergency Medical Services in the Department of
- 17 Health shall maintain the official flag and have the
- 18 responsibility to implement the provisions of this act and
- 19 oversee the production, acquisition and distribution of the
- 20 flag.
- 21 Section 4. Limitation.
- 22 Authorized utilization of the emergency medical services
- 23 memorial flag by the Commonwealth or an entity of the
- 24 Commonwealth shall not constitute a presumption of eligibility
- 25 or be admissible as evidence for a claim under the act of June
- 26 24, 1976 (P.L.424, No.101), referred to as the Emergency and Law
- 27 Enforcement Personnel Death Benefits Act.
- 28 Section 5. Effective date.
- 29 This act shall take effect in 60 days.
