AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," further providing for background checks of prospective employees and conviction of employees of certain offenses. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. five (5) years immediately preceding the date of the report, of
