## AN ACT

- 1 Amending the act of August 15, 1961 (P.L.987, No.442), entitled
- "An act relating to public works contracts; providing for
- prevailing wages; imposing duties upon the Secretary of Labor
- and Industry; providing remedies, penalties and repealing
- 5 existing laws," further providing for administration.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 7 of the act of August 15, 1961 (P.L.987,
- 9 No.442), known as the Pennsylvania Prevailing Wage Act, amended
- 10 August 9, 1963 (P.L.653, No.342), is amended to read:
- 11 Section 7. Duty of Secretary. -- The secretary shall determine
- 12 the prevailing wage rate for each county, utilizing occupational
- 13 wage rate data determined by the Center for Workforce and
- 14 Analysis of the department as the basis for the determination,
- 15 and shall, after consultation with the advisory board, determine
- 16 the general prevailing minimum wage rate in the locality in
- 17 which the public work is to be performed for each craft or

- 1 classification of all workmen needed to perform public work
- 2 contracts during the anticipated term thereof: Provided,
- 3 however, That employer and employe contributions for employe
- 4 benefits pursuant to a bona fide collective bargaining agreement
- 5 shall be considered an integral part of the wage rate for the
- 6 purpose of determining the minimum wage rate under this act.
- 7 Nothing in this act, however, shall prohibit the payment of more
- 8 than the general prevailing minimum wage rate to any workman
- 9 employed on public work. The secretary shall forthwith give
- 10 notice by mail of all determinations of general prevailing
- 11 minimum wage rates made pursuant to this section to any
- 12 representative of any craft, any employer or any representative
- 13 of any group of employers, who shall in writing request the
- 14 secretary so to do.
- 15 Section 2. This act shall take effect in 60 days.
