20	"Sports official." A person who supervises children

23	coach, assistant coach, athletic trainer, team attendant, game
24	manager, instructor or a person at a sports program who enforces
25	the rules of a sporting event sponsored by a sports program of a
26	nonprofit association or a for-profit association, including,
27	but not limited to, an umpire or referee, whether receiving
28	remuneration or holding the position as a volunteer.
