Section 6373(4) of Title 42 of the Pennsylvania Consolidated Statutes is amended to read: 7 § 6373. Powers and duties. 8 9 The commission shall have the power and is required to do the 10 following: * * * 11 12 (4) Collect[, compile and publish such statistical] and 13 [other] <u>analyze</u> data [as may be needed] to [accomplish] 14 identify trends and evidence based programs and practices to 15 ensure reasonable and efficient administration of the 16 juvenile [courts] justice system; make recommendations 17

7	COLLECT AND ANALYZE DATA TO IDENTIFY TRENDS AND TO DETERMINE
8	THE EFFECTIVENESS OF PROGRAMS AND PRACTICES TO ENSURE THE
9	REASONABLE AND EFFICIENT ADMINISTRATION OF THE JUVENILE COURT
10	SYSTEM; MAKE RECOMMENDATIONS CONCERNING EVIDENCE-BASED
11	PROGRAMS AND PRACTICES TO JUDGES, THE ADMINISTRATIVE OFFICE
12	OF PENNSYLVANIA COURTS AND OTHER APPROPRIATE ENTITIES; AND
13	POST RELATED INFORMATION ON THE COMMISSION'S PUBLICLY
14	ACCESSIBLE INTERNET WEBSITE.
15	Section 2. This act shall take effect in 60 days.
