AN ACT

Amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, further providing for powers and duties of Municipal Police Officers' Education and Training 4 Commission. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Section 2164(15) of Title 53 of the Pennsylvania Consolidated Statutes is amended to read: 8 § 2164. Powers and duties of commission. 10 The powers and duties of the commission shall be as follows: * * * 11 12 (15) To grant waivers of mandatory basic training to 13 police officers or Federal law enforcement officers who have 14 successfully completed previous equivalent training or who 15 have acceptable full time police or law enforcement 16 experience, or both. WITH RESPECT TO MANDATORY BASIC TRAINING: 17

1	(I) TO GRANT WAIVERS OF MANDATORY BASIC TRAINING TO
2	POLICE OFFICERS WHO HAVE SUCCESSFULLY COMPLETED PREVIOUS
3	EQUIVALENT TRAINING OR WHO HAVE ACCEPTABLE FULL-TIME
4	[POLICE] EXPERIENCE, OR BOTH.
5	(II) TO GRANT WAIVERS OF PORTIONS OF MANDATORY BASIC
6	TRAINING TO FEDERAL LAW ENFORCEMENT OFFICERS AND MILITARY
7	POLICE OFFICERS WHO HAVE SUCCESSFULLY COMPLETED PREVIOUS
8	EQUIVALENT TRAINING. IN ORDER TO BE CERTIFIED BY THE
9	COMMISSION, FEDERAL LAW ENFORCEMENT OFFICERS AND MILITARY
10	POLICE OFFICERS SHALL FULFILL BASIC POLICE TRAINING
11	REQUIREMENTS AND MEET THE MINIMUM STANDARDS REQUIRED FOR
12	CERTIFICATION.
13	Section 2. This act shall take effect in 60 days.
