AN ACT

Amending the act of February 9, 1999 (P.L.1, No.1), entitled "An act providing for borrowing for capital facilities; 2 conferring powers and duties on various administrative 3 agencies and officers; making appropriations; and making repeals," in capital facilities, further providing for definitions, for legislative procedures, FOR REPORTS RELATED TO REDEVELOPMENT ASSISTANCE CAPITAL PROJECTS and for 7 8 appropriations and limitations on projects; providing for review of proposals; and further providing for funding and 9 administration of projects. 10

- The General Assembly of the Commonwealth of Pennsylvania 11
- 12 hereby enacts as follows:
- 13 Section 1. The definitions of "capital project" and
- "redevelopment assistance capital project" in section 302 of the 14
- 15 act of February 9, 1999 (P.L.1, No.1), known as the Capital

- 1 Facilities Debt Enabling Act, amended July 4, 2004 (P.L.516,
- 2 No.67) and December 22, 2005 (P.L.454, No.87), are amended and
- 3 the section is amended by adding definitions to read:
- 4 Section 302. Definitions.
- 5 The following words and phrases when used in this chapter
- 6 shall have the meanings given to them in this section unless the
- 7 context clearly indicates otherwise:
- 8 * * *
- 9 "Applicant." A person that is seeking funding for a
- 10 redevelopment assistance capital project that has been listed in
- 11 <u>a capital project itemization bill and that is one of the</u>
- 12 <u>following:</u>
- 13 <u>(1) A redevelopment authority.</u>
- 14 (2) An industrial development authority.
- 15 (3) A general purpose unit of local government.
- 16 (4) A local development district that has an agreement
- 17 with a general purpose unit of local government under which
- 18 the unit assumes ultimate responsibility for debt incurred to
- obtain the non-State financial participation.
- 20 (5) A public authority established pursuant to the laws
- of this Commonwealth.
- 22 (6) An industrial development agency:
- (i) which has been certified as an industrial
- development agency by the Pennsylvania Industrial
- 25 Development Authority Board under the act of May 17, 1956
- 26 (1955 P.L.1609, No.537), known as the Pennsylvania
- 27 <u>Industrial Development Authority Act; and</u>
- 28 (ii) which is itself or which is acting through a
- 29 <u>wholly owned subsidiary that is exempt from Federal</u>
- 30 <u>taxation under section 501(c)(3) of the Internal Revenue</u>

- 2 "Capital project." A community college, flood control,
- 3 highway, public improvement, redevelopment assistance capital or
- 4 <u>transportation assistance</u> project which is financed by debt or
- 5 by other funds and which meets all of the following:
- 6 (1) Is an undertaking to construct, repair, renovate,
- 7 improve, equip, furnish or acquire any:
- 8 (i) building, structure, facility, infrastructure or
- 9 physical public betterment or improvement;
- 10 (ii) land or rights in land; or
- 11 (iii) furnishings, machinery, apparatus or equipment
- for a building, structure, facility or physical public
- 13 betterment or improvement.
- 14 (2) Is designated in a [capital budget] <u>capital project</u>
- itemization bill as a capital project.
- 16 (3) Has an estimated useful life in excess of five
- 17 years.
- 18 (4) Has an estimated financial cost in excess of
- 19 \$100,000. This paragraph does not apply to original equipment
- or furnishings for previously authorized public improvement
- 21 projects.
- 22 [Capital projects are categorized as flood control projects,
- 23 highway projects, public improvement projects, redevelopment
- 24 assistance capital projects and transportation assistance
- 25 projects.1

- 27 <u>"Legislative session." A two-year period beginning December</u>

- 8 <u>not include</u> highways, bridges, waste disposal facilities,
- 9 sewage facilities or water facilities. This paragraph

- (i) [Water] Storm water, water or sewer
- infrastructure, or <u>tunnels</u>, bridges or roads, when
- 13 [included as part of a business or industrial park
- facility] <u>associated with a project that is part of an</u>
- economic development project.
- 16 (ii) Hospital facilities and capital improvements
- for hospital facilities.
- 18 (2) [Are economic development projects which] <u>Is a</u>
- 19 <u>project which will</u> generate substantial increases in <u>or</u>
- 20 <u>maintain current levels of employment</u>, tax revenues or other
- 21 measures of economic activity. This paragraph includes
- 22 projects with cultural, historical or civic significance.
- 23 (3) [Are facilities which have] <u>Is a project that has</u> a
- 24 regional or multijurisdictional impact.
- 25 (4) [Are] <u>Is</u> eligible for tax-exempt bond funding under
- 26 existing Federal law and regulations.
- 27 (5) [Have a] Has at least a 50% non-State financial
- 28 participation documented at the time of application,
- 29 including a portion of any funds reserved for future physical
- 30 maintenance and operation of the [facilities] project:

1 (i) at least half of which is secured funding; 2 (ii) toward which the only noncash non-State 3 financial participation permitted is land or fixed assets which have a substantial useful life and are directly 4 5 related to the project; (iii) toward which State funds from other programs 6 7 may not be used; and 8 (iv) toward which funds from Federal sources may be 9 used. 10 (6) [Have] <u>Has</u> a total project cost of at least \$1,000,000. 11 12 [Applicants shall be one of the following: (7)(i) A redevelopment authority. 13 14 (ii) An industrial development authority. 15 (iii) A general purpose unit of local government. 16 A local development district which has an 17 agreement with a general purpose unit of local government 18 under which the unit assumes ultimate responsibility for 19 debt incurred to obtain the 50% non-State participation 20 required by paragraph (5). 21 Any public authority established pursuant to the 22 laws of this Commonwealth. 23 An industrial development agency which has been 24 certified as an industrial development agency by the 25 Pennsylvania Industrial Development Authority Board 26 pursuant to the act of May 17, 1956 (1955 P.L.1609, 27 No.537), known as the Pennsylvania Industrial Development 28 Authority Act, and which is itself or which is acting 29 through a wholly owned subsidiary which is exempt from

- 14 (a) Legislative process. -- A capital budget prepared in
- 15 accordance with this chapter shall be submitted for each fiscal
- 16 year by the Governor to the General Assembly and shall be
- 17 considered in the form of a bill as provided in Article III of
- 18 the Constitution of Pennsylvania.
- 19 (b) Itemization bill.--

(4) The capital budget bill must state the maximum amount of such obligations which may be incurred in the ensuing fiscal year to provide funds for and towards the financial costs of each category of capital projects, which shall be by the issue of general obligations of the Commonwealth.]

(1) At least once each legislative session, the Governor shall submit a capital project itemization bill to the General Assembly specifically itemizing the capital projects to be financed from the proceeds of obligations of the Gommonwealth. No redevelopment assistance capital project may receive funds unless the project is itemized in a capital project itemization bill enacted within ten years of the date the project is approved under section 318 or the project has been approved by the secretary on or before December 31, 2011. Each capital project must be listed under its category and include all of the following:

(i) A specific description of the capital project, including the municipality in which the capital project is located.

(ii) Estimated financial cost of the capital project.

(iii) The fund to be charged with the repayment of the obligation to be incurred.

(2) Beginning January 1, 2012, a redevelopment

assistance capital project which has been itemized but has

not been approved by the secretary on or before December 31,

2011, may not receive funding unless the redevelopment

- 3 AT LEAST ONCE EACH LEGISLATIVE SESSION, THE GOVERNOR SHALL

- 5 ASSEMBLY SPECIFICALLY ITEMIZING THE CAPITAL PROJECTS TO BE
- 6 FINANCED FROM THE PROCEEDS OF OBLIGATIONS OF THE COMMONWEALTH.
- 7 NO REDEVELOPMENT ASSISTANCE CAPITAL PROJECT MAY RECEIVE FUNDS

- 21 [(c) Timing.--Each year the Governor shall submit a capital
- 22 budget bill for the ensuing fiscal year.]
- 23 (d) [Additional bills] Debt authorization bill.--At the time
- 24 the Governor submits the [capital budget or a supplement]
- 25 General Appropriation Bill for a fiscal year, the Governor
- 26 shall, to the extent the debt to be incurred is not within the
- 27 limits of legislation then in force authorizing the incurring of
- 28 debt, submit [additional bills for each category of capital
- 29 projects, a capital budget bill authorizing the [incurring of
- 30 debt] maximum amount of general obligation debt to be incurred

- 1 <u>in the ensuing fiscal year</u> to provide funds for and towards the
- 2 payment of the financial costs of capital projects in [such]
- 3 each category of capital projects which have been specifically
- 4 itemized in a [capital budget for the same or any prior year]
- 5 <u>capital project itemization bill</u>.
- 6 (e) Categories.--Each [debt-authorizing bill] capital budget
- 7 bill must do all of the following:
- 8 (1) State the category of capital projects to be
- 9 financed by the debt so authorized but need not enumerate the
- 10 capital projects to be financed.
- 11 (2) Authorize the incurring of debt in not less than the
- amount of the financial cost of all capital projects in such
- category not covered by a previous debt authorization,
- including any overall allowance for contingencies.
- 15 (3) State the estimated useful lives of the capital
- projects to be financed in such detail as may be requisite if
- capital projects of varying useful lives are to be combined
- 18 for financing purposes.
- 19 (4) State the maximum term of the debt to be incurred.
- 20 SECTION 313.1. REPORTS RELATED TO REDEVELOPMENT ASSISTANCE
- 21 CAPITAL PROJECTS.
- 22 THE SECRETARY OF THE BUDGET SHALL, WITHIN TEN DAYS OF THE

- 8 WILL BE PAID [OR REFINANCED] IN THE SUCCEEDING FOUR QUARTERS.

- 10 (P.L.335, No.48), is amended to read:
- 11 Section 317. Appropriation for and limitation on redevelopment
- 12 assistance capital projects.
- 13 (a) Appropriation. -- The amount necessary to pay principal of
- 14 and interest on all obligations issued to provide funds for
- 15 redevelopment assistance capital projects shall be appropriated
- 16 from the General Fund and shall be transferred to the Capital
- 17 Debt Fund upon authorization by the Governor.
- 18 (b) Limitation.--The maximum amount of redevelopment
- 19 assistance capital projects undertaken by the Commonwealth for
- 20 which obligations are outstanding shall not exceed, in
- 21 aggregate, [\$4,050,000,000.] <u>\$3,500,000,000</u>. Beginning July 1,
- 22 2012, and each July 1 thereafter until July 1, 2020, the sum of
- 23 the maximum amount of outstanding obligations for redevelopment
- 24 assistance capital projects shall be decreased by \$50,000,000.
- 25 Beginning July 1, 2020, and each July 1 thereafter until the sum

- 7 (a) [Officers.--The Secretary of the Budget shall review and
- 8 shall approve or disapprove applications for redevelopment
- 9 assistance capital projects.] (Reserved).
- 10 (a.1) Application. -- An applicant shall submit an application
- 11 to the office consistent with the timeline established by the
- 12 office requesting a grant for a redevelopment assistance capital
- 13 project. The proposal must be on the form required by the office
- 14 and must include or demonstrate all of the following:
- 15 (1) The applicant's name and address.
- 16 (2) The location of the project.
- 17 (3) An estimate of the cost of the project, prepared by
- an engineer or other qualified professional.
- 19 <u>(4) A statement of the amount of the project grant</u>
- sought, including a statement as to the financial necessity
- 21 for the project grant.
- 22 (5) A statement that the applicant held at least one
- 23 public informational meeting regarding the redevelopment

- 10 or 180 days of notification under subsection (a.2), whichever is
- 11 less, no contract may be executed by the office for the grant.
- 12 (b) Time period. -- State funding for approved redevelopment
- 13 assistance capital projects shall be paid over not less than a
- 14 36-month period unless the [Secretary of the Budget] secretary
- 15 authorizes a shorter period.
- 16 (c) Costs.-- Land acquisition is a permissible State-funded
- 17 expenditure if the acquisition cost is supported by an appraisal
- 18 done by a certified appraiser.
- 19 (e) Verification. -- Redevelopment assistance capital project
- 20 cost estimates must be verified by the [Office of the Budget]
- 21 office or its designated agent before final approval is given to
- 22 a project application. Cost estimates include total project
- 23 cost, projected use for State and non-State funds and a year-by-
- 24 year schedule of costs for the entire project construction
- 25 phase.
- 26 (f) Bids.-- Notwithstanding any other provision of law, the
- 27 solicitation of a minimum of three written bids for all
- 28 contracted construction work on redevelopment assistance capital
- 29 projects shall be the sole requirement for the composition,
- 30 solicitation, opening and award of bids on such projects.

- 1 Notwithstanding the foregoing, the construction work shall be
- 2 performed subject to the act of March 3, 1978 (P.L.6, No.3),
- 3 known as the Steel Products Procurement Act.
- 4 (g) Review and audit. -- Redevelopment assistance capital
- 5 projects shall be reviewed at regular intervals by the [Office
- 6 of the Budget] office or its designated agent during the funding
- 7 phase to ensure financial and program compliance. A final
- 8 closeout audit shall be performed by the [Office of the Budget]
- 9 office or its designated agent for all projects.
- 10 (h) Fee.--To pay for administrative expenses related to
- 11 redevelopment assistance capital projects funded by Commonwealth
- 12 general obligation bonds, the [Office of the Budget] office may
- 13 charge a fee against proceeds from bonds and notes which were
- 14 sold to finance construction or acquisition costs of projects.
- 15 (i) Grant administration. -- In the event any applicant does
- 16 not administer the grant, the applicant shall enter into a
- 17 cooperation agreement with the entity administering the grant,
- 18 which agreement shall be subject to the approval of the [Office
- 19 of the Budget] office.
- 20 (j) Moratorium. -- If the Governor-elect is not currently
- 21 holding the office of Governor as a result of a general election
- 22 <u>at which a Governor is elected, no redevelopment assistance</u>
- 23 capital project may be approved in the period between the date
- 24 of the general election at which the Governor-elect was elected
- 25 and the third Tuesday of January next following the election.
- 26 (k) Guidelines.--Within 60 days of the effective date of
- 27 this subsection, the office shall establish quidelines
- 28 concerning the administration of and approval process for
- 29 redevelopment assistance capital projects. The guidelines shall,
- 30 at a minimum, establish application timelines, application

- 1 content and the review, evaluation and award criteria and
- 2 process. In establishing the evaluating criteria, the office may
- 3 give preference to an applicant with a project that has at least
- 4 <u>a 75% non-State financial participation. The guidelines must be</u>
- 5 posted on the Internet website of the office.
- 6 (L) DISCLOSURE. -- UPON A REDEVELOPMENT ASSISTANCE CAPITAL
- 7 PROJECT BEING APPROVED, THE OFFICE SHALL POST ON ITS INTERNET
- 8 WEBSITE THE DATE OF APPROVAL OF THE PROJECT, THE NAME OF THE
- 9 APPLICANT, A SHORT DESCRIPTION OF THE PROJECT, THE LOCATION OF
- 10 THE PROJECT, INCLUDING THE MUNICIPALITY IN WHICH IT IS LOCATED,
- 11 AND THE AMOUNT OF THE PROJECT GRANT APPROVED FOR THE PROJECT.
- 12 Section 5. The amendment of the definition of "redevelopment
- 13 assistance capital project" in section 302 of the act shall
- 14 apply to capital projects that have not been approved by the
- 15 Secretary of the Budget on or before December 31, 2011.
- 16 Section 6. This act shall take effect immediately.
