A RESOLUTION

- Designating the month of October 2011 as "Crime Prevention Month" in Pennsylvania.
- 3 WHEREAS, The National Crime Prevention Council was founded in
- 4 1982 to manage the National Citizens' Crime Prevention Campaign
- 5 and McGruff the Crime Dog and to administer the Crime Prevention
- 6 Coalition of America; and
- 7 WHEREAS, The modern mission of the National Crime Prevention
- 8 Council is to help people keep themselves, their families and
- 9 their communities safe from crime through various programs,
- 10 publications and public service announcements; and
- 11 WHEREAS, The National Crime Prevention Council has annually
- 12 designated October "Crime Prevention Month" as the official

- 1 month for recognizing and celebrating the practice of crime
- 2 prevention since 1984; and
- 3 WHEREAS, The National Crime Prevention Council partners with
- 4 prevention organizations, justice advocates and other
- 5 professionals to build and sustain relationships with citizens
- 6 and public officials to promote a national crime prevention
- 7 agenda that will reduce the incidence of crimes, while helping
- 8 communities identify and address the underlying causes of
- 9 crimes; and
- 10 WHEREAS, October Crime Prevention Month brings together
- 11 government agencies, civic groups, schools, businesses and youth
- 12 organizations in a joint effort to promote awareness of
- 13 important issues such as victimization, volunteerism and
- 14 creating healthier, safer communities; therefore be it
- RESOLVED, That the House of Representatives designate the
- 16 month of October 2011 as "Crime Prevention Month" in
- 17 Pennsylvania.
