## A RESOLUTION

- Supporting the value of the Pennsylvania craft beer industry by recognizing the month of February 2012 as "PA Craft Beer"
- Month" in Pennsylvania.
- 4 WHEREAS, Since 2010, Pennsylvania is home to 78 craft
- 5 breweries, 332 wholesalers and more than 15,000 malt beverage
- 6 retail establishments; and
- 7 WHEREAS, The top 50 breweries in the United States have five
- 8 Pennsylvania craft breweries present on that list; and
- 9 WHEREAS, Out of the five Pennsylvania craft breweries in the
- 10 top 50, Yuengling and Samuel Adams reside in the top five, just
- 11 below America's giants, Anheuser-Busch and MillerCoors; and
- 12 WHEREAS, The Pennsylvania beer industry directly and
- 13 indirectly employs approximately 60,000 workers; and
- 14 WHEREAS, In 2010, the Pennsylvania beer industry directly and
- 15 indirectly generated nearly \$7 billion into the State's economy;
- 16 and

- 1 WHEREAS, In 2010, the Pennsylvania beer industry contributed
- 2 over \$1 billion in tax revenue to Federal, State and local
- 3 governments; and
- 4 WHEREAS, Pennsylvania's craft brewers provide philanthropy
- 5 throughout this Commonwealth by way of event hosting, cash and
- 6 product contributions and volunteerism; and
- 7 WHEREAS, Pennsylvania's craft brewers use local ingredients
- 8 to brew and package their products; and
- 9 WHEREAS, Increased State and local support of Pennsylvania's
- 10 craft breweries is necessary for the pride and prosperity of
- 11 this Commonwealth and its residents; therefore be it
- 12 RESOLVED, That the House of Representatives:
- 13 (1) support the success of Pennsylvania craft brewers;
- 14 (2) recognize the significant contributions of the beer
- industry to the Commonwealth of Pennsylvania; and
- 16 (3) encourage appreciation of the art that Pennsylvania
- brewers have mastered by celebrating the month of February
- 18 2012 as "PA Craft Beer Month" in Pennsylvania.
