AN ACT

- 1 Amending the act of February 1, 1966 (1965 P.L.1656, No.581),
- entitled "An act concerning boroughs, and revising, amending
- and consolidating the law relating to boroughs," further
- 4 providing for regulation of contracts, for evasion of
- advertising requirements and for certain purchase contracts.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 1402(a), (a.1) and (d) of the act of
- 9 February 1, 1966 (1965 P.L.1656, No.581), known as The Borough
- 10 Code, amended or added July 10, 1990 (P.L.383, No.90), December
- 11 18, 1996 (P.L.1141, No.171), December 18, 1996 (P.L.1156, No.
- 12 176), December 20, 1996 (P.L.1497, No.193) and October 27, 2010
- 13 (P.L., No.87), are amended and the section is amended by
- 14 adding a subsection to read:
- 15 Section 1402. Regulation of Contracts. -- (a) All contracts
- 16 or purchases in excess of [ten thousand dollars (\$10,000)]
- 17 <u>twenty-five thousand dollars (\$25,000) subject to adjustment</u>
- 18 under subsection (a.2), except those hereinafter mentioned,

- 1 shall not be made except with and from the lowest responsible
- 2 bidder after due notice in one newspaper of general circulation
- 3 in the borough, at least two times at intervals of not less than
- 4 three days where daily newspapers of general circulation are
- 5 available for such publication, in case of weekly newspapers,
- 6 such notice once a week for two successive weeks. The first
- 7 advertisement shall be published not more than forty-five days
- 8 and the second advertisement not less than ten days prior to the
- 9 date fixed for the opening of bids. Advertisements for contracts
- 10 or purchases shall also be posted in a conspicuous place within
- 11 the borough. Advertisements for contracts and purchases shall
- 12 contain the date, time and location for opening of bids and
- 13 shall state the amount of the performance bond determined under
- 14 subsection (c). The amount of the contract shall in all cases,
- 15 whether of straight sale price, conditional sale, bailment
- 16 lease, or otherwise, be the entire amount which the borough pays
- 17 to the successful bidder or his assigns in order to obtain the
- 18 services or property, or both, and shall not be construed to
- 19 mean only the amount which is paid to acquire title or to
- 20 receive any other particular benefit or benefits of the whole
- 21 bargain. In awarding contracts, council shall have the right to
- 22 take into consideration such other factors as the availability,
- 23 cost and quality of service.
- 24 (a.1) Written or telephonic price quotations from at least
- 25 three qualified and responsible contractors shall be requested
- 26 for all contracts that exceed [four thousand dollars (\$4,000)]
- 27 <u>seven thousand dollars (\$7,000) subject to adjustment under</u>
- 28 <u>subsection (a.2)</u> but are less than the amount requiring
- 29 advertisement and competitive bidding or, in lieu of price
- 30 quotations, a memorandum shall be kept on file showing that

- 1 fewer than three qualified contractors exist in the market area
- 2 within which it is practicable to obtain quotations. A written
- 3 record of telephonic price quotations shall be made and shall
- 4 contain at least the date of the quotation, the name of the
- 5 contractor and the contractor's representative, the
- 6 construction, reconstruction, repair, maintenance or work which
- 7 was the subject of the quotation and the price. Written price
- 8 quotations, written records of telephonic price quotations and
- 9 memoranda shall be retained for a period of three years.
- 10 (a.2) (1) Every five years, beginning with the year in
- 11 which this subsection becomes applicable to contracts and
- 12 purchases, the Department of Labor and Industry shall calculate
- 13 the average percentage change in the Consumer Price Index for
- 14 All Urban Consumers (CPI-U) for the United States city average
- 15 for all items as published by the United States Department of
- 16 Labor, Bureau of Labor Statistics, for the preceding five-year
- 17 period.
- 18 (2) The amount at which competitive bidding is required
- 19 under subsection (a) and the amount at which written or
- 20 telephonic price quotations are required under subsection (a.1)
- 21 shall be adjusted every five years as follows:
- 22 (i) In the case of competitive bidding, the positive
- 23 percentage change, as determined in accordance with clause (1),
- 24 shall be multiplied by the amount applicable under subsection
- 25 (a) for the current five-year period and the product thereof
- 26 shall be added to the amount applicable under subsection (a) for
- 27 the current five-year period, with the result rounded to the
- 28 nearest multiple of one hundred dollars (\$100).
- 29 <u>(ii) In the case of written or telephonic price quotations,</u>
- 30 the positive percentage change, as determined in accordance with

- 1 clause (1), shall be multiplied by the amount applicable under
- 2 <u>subsection (a.1) for the current five-year period and the</u>
- 3 product thereof shall be added to the amount applicable under
- 4 <u>subsection (a.1) for the current five-year period, with the</u>
- 5 result rounded to the nearest multiple of one hundred dollars
- 6 (\$100).
- 7 (3) The determination required under clause (1) and the
- 8 <u>calculation of the adjustments required under clause (2) shall</u>
- 9 <u>be made in the period between October 1 and November 15 of the</u>
- 10 year following the effective date of this subsection, and
- 11 between October 1 and November 15 of each successive year.
- 12 <u>(4) The adjusted amounts obtained in accordance with clause</u>
- 13 (2) shall become effective January 1 for the five-year period
- 14 <u>following the year in which the determination required under</u>
- 15 clause (1) is made.
- 16 (5) The Department of Labor and Industry shall give notice
- 17 in the Pennsylvania Bulletin prior to January 1 of each calendar
- 18 year in which the percentage change determined in accordance
- 19 with clause (1) and the amounts, whether adjusted or unadjusted
- 20 in accordance with clause (2), at which competitive bidding is
- 21 required under subsection (a) and written or telephonic price
- 22 quotations are required under subsection (a.1) for the five-year
- 23 period beginning the first day of January after publication of
- 24 the notice.

- 27 (d) The contracts or purchases made by council, which shall
- 28 not require advertising, bidding or price quotations as
- 29 hereinbefore provided, are as follows:
- 30 (1) Those for maintenance, repairs or replacements for

- 1 water, electric light or public works of the borough, provided
- 2 they do not constitute new additions, extensions or enlargements
- 3 of existing facilities and equipment, but a bond may be required
- 4 by council, as in other cases of work done;
- 5 (2) Those made for improvements, repairs and maintenance of
- 6 any kind, made or provided by any borough, through its own
- 7 employes: Provided, That all materials used for street
- 8 improvement, maintenance and/or construction in excess of [four
- 9 thousand dollars (\$4,000)] the amount specified or adjusted
- 10 <u>under subsection (a.1)</u> be subject to the relevant price
- 11 quotation or advertising requirements contained herein;
- 12 (3) Those where particular types, models or pieces of new
- 13 equipment, articles, apparatus, appliances, vehicles or parts
- 14 thereof are desired by council, which are patented and
- 15 manufactured or copyrighted products;
- 16 (3.1) Those for used equipment, articles, apparatus,
- 17 appliances, vehicles or parts thereof being purchased from a
- 18 public utility.
- 19 (4) Those involving any policies of insurance or surety
- 20 company bonds; those made for public utility service under
- 21 tariffs on file with the Pennsylvania Public Utility Commission;
- 22 those made with another political subdivision, or a county, the
- 23 Commonwealth of Pennsylvania, the Federal Government, any agency
- 24 of the Commonwealth or the Federal Government, or any municipal
- 25 authority, including the sale, leasing or loan of any supplies
- 26 or materials by the Commonwealth or the Federal Government or
- 27 their agencies. The price thereof shall not be in excess of that
- 28 fixed by the Commonwealth, the Federal Government, or their
- 29 agencies;
- 30 (5) Those involving personal or professional services.

- 1 (6) Those made relating to the purchase of electricity and
- 2 <u>associated energy and related services by a borough owning or</u>
- 3 operating electric generation or distribution facilities on the
- 4 <u>effective date of this section with any of the following:</u>
- 5 (i) A political subdivision.
- 6 (ii) Another state.
- 7 <u>(iii) The Commonwealth or an agency thereof.</u>
- 8 <u>(iv) The Federal Government.</u>
- 9 <u>(v) A private corporation.</u>
- 10 (vi) An electric cooperative corporation under 15 Pa.C.S.
- 11 Ch. 73 (relating to electric cooperative corporations).
- 12 (vii) A non-profit membership corporation. As used in this
- 13 <u>subclause</u>, the term "non-profit membership corporation" means an
- 14 entity, the membership of which:
- 15 (A) consists solely of Pennsylvania boroughs, such as a
- 16 consortium, buying group or municipal power agency under section
- 17 2471.2; or
- 18 (B) consists of Pennsylvania boroughs and political
- 19 subdivisions of another state or states.
- 20 (viii) An electric cooperative of another state.
- 21 Nothing in this clause shall prohibit council from engaging in
- 22 <u>advertising</u>, bidding or price quotations if the council
- 23 determines that the advertising, bidding or price quotations are
- 24 <u>in the public interest.</u>
- 25 * * *
- 26 Section 2. Sections 1403(a) and 1405 of the act, amended
- 27 July 10, 1990 (P.L.383, No.90), are amended to read:
- 28 Section 1403. Evasion of Advertising Requirements. -- (a) No
- 29 member or members of council shall evade the provisions of
- 30 section 1402 hereof as to advertising for bids, by purchasing or

- 1 contracting for services and personal properties piecemeal for
- 2 the purpose of obtaining prices under [ten thousand dollars
- 3 (\$10,000)] the amount specified or adjusted under section
- 4 1402(a) upon transactions, which transactions should, in the
- 5 exercise of reasonable discretion and prudence, be conducted as
- 6 one transaction amounting to more than [ten thousand dollars
- 7 (\$10,000)] the amount specified or adjusted under section
- 8 1402(a). This provision is intended to make unlawful the evading
- 9 of advertising requirements by making a series of purchases or
- 10 contracts, each for less than the advertising requirement price,
- 11 or by making several simultaneous purchases or contracts, each
- 12 below said price, when, in either case, the transactions
- 13 involved should have been made as one transaction for one price.
- 14 Any members of council who so vote in violation of this
- 15 provision and who know that the transaction upon which they so
- 16 vote is or ought to be a part of a larger transaction and that
- 17 it is being divided in order to evade the requirements as to
- 18 advertising for bids, shall be jointly and severally subject to
- 19 surcharge for ten percent of the full amount of the contract or
- 20 purchase. Whenever it shall appear that a member of council may
- 21 have voted in violation of this section but the purchase or
- 22 contract on which he so voted was not approved by council, this
- 23 section shall be inapplicable.
- 24 * * *
- 25 Section 1405. Separate Bids for Plumbing, Heating,
- 26 Ventilating and Electrical Work. -- In the preparation for the
- 27 erection, construction and alteration of any public building,
- 28 when the entire cost of such work shall exceed [ten thousand
- 29 dollars (\$10,000)] the amount specified or adjusted under
- 30 <u>section 1402(a)</u>, the architect, engineer, or other person

- 1 preparing such specifications may, if so requested by the
- 2 borough council, prepare separate specifications for the
- 3 plumbing, heating, ventilating and electrical work. The person
- 4 or persons authorized to enter into contracts for the erection,
- 5 construction or alteration of such public buildings may, if such
- 6 separate specifications shall have been proposed, receive
- 7 separate bids upon each of the said branches of work and shall
- 8 thereupon award the contract for the same to the lowest
- 9 responsible bidder for each of said branches.
- 10 Section 3. This act shall apply to contracts and purchases
- 11 advertised after December 31 of the year in which this section
- 12 takes effect.
- 13 Section 4. This act shall take effect immediately.
