## AN ACT

1	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2	Statutes, DEFINING "INTERACTIVE WIRELESS COMMUNICATIONS +
3	DEVICE"; FURTHER PROVIDING FOR JUNIOR DRIVER'S LICENSE AND
4	FOR SUSPENSION OF OPERATING PRIVILEGE; providing for
5	prohibiting use of <del>electronic</del> INTERACTIVE wireless
6	communications devices while operating motor vehicles; AND
7	FURTHER PROVIDING FOR DUTY OF DRIVER IN CONSTRUCTION AND
8	MAINTENANCE AREAS OR ON HIGHWAY SAFETY CORRIDORS, FOR DUTY OF
9	DRIVER IN EMERGENCY RESPONSE AREAS, FOR ACCIDENT REPORT
10	FORMS, FOR DEPARTMENT TO COMPILE, TABULATE AND ANALYZE
11	ACCIDENT REPORTS, FOR TELEVISION EQUIPMENT AND FOR RESTRAINT
12	SYSTEMS.
13	THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA
14	DECLARES THAT THE PART OF THIS ACT THAT LIMITS THE NUMBER OF
15	PASSENGERS A JUNIOR DRIVER MAY TRANSPORT IN A MOTOR VEHICLE AT
16	ONE TIME MAY BE REFERRED TO AS LACEY'S LAW IN HONOR OF LACEY
17	GALLAGHER.
18	The General Assembly of the Commonwealth of Pennsylvania

20	Section 1. Title 75 of the Pennsylvania Consolidated

22	§ 3316. Prohibiting use of electronic wireless communications

2	(a) Prohibition. Except as otherwise provided in this
3	section, no person shall operate a motor vehicle upon a public
4	highway and use an electronic wireless communications device to
5	send, read or write a text message while the vehicle is in
6	motion. A person does not send, read or write a text message
7	when the person reads, selects or enters a phone number or name
8	in an electronic wireless communications device for the purpose
9	of making a phone call. A conviction or detainment under this
10	subsection by State or local law enforcement agencies shall
11	occur only as a secondary action when a driver of a motor
12	vehicle has been detained or convicted of any other provision of
13	this title.
14	(b) Applicability. This section shall not apply to a person
15	operating:
16	(1) an emergency vehicle; or
17	(2) while in the performance of their official duties: a
18	police officer, peace officer or coroner; or a member of a
19	fire department, district or company.
20	(c) Penalty. Any person who violates this section shall be
21	guilty of a summary offense with a maximum fine of \$100. A
22	violation of subsection (a) shall not result in the accumulation
23	of points under this title.
24	(d) Local ordinances. This section supersedes and preempts
25	all ordinances of any municipality with regard to the use of an
26	electronic wireless communications device by the driver of a

- DRIVER'S IMMEDIATE FAMILY UNLESS THE JUNIOR DRIVER IS
- 14 <u>ACCOMPANIED BY A PARENT OR LEGAL GUARDIAN. A JUNIOR DRIVER</u>
- 15 SHALL NOT DRIVE A VEHICLE WITH MORE THAN ONE PASSENGER UNDER
- 16 18 YEARS OF AGE WHO IS NOT A MEMBER OF THE DRIVER'S IMMEDIATE
- 17 FAMILY UNLESS THE JUNIOR DRIVER IS ACCOMPANIED BY A PARENT OR
- 18 LEGAL GUARDIAN IF THE JUNIOR DRIVER HAS BEEN INVOLVED IN AN
