## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, providing for special
- registration plates for recipients of the Silver Star, Bronze
- 4 Star and Bronze Star with Valor.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 75 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding sections to read:
- 9 § 1366. Special plates for recipients of Silver Star.
- 10 <u>Upon application of any person who is a recipient of the</u>
- 11 Silver Star, accompanied by a fee of \$10 \$20 which shall be in
- 12 addition to the annual registration fee and by such
- 13 <u>documentation as the department shall require</u>, the department
- 14 <u>shall issue to the person a special registration plate</u>
- 15 <u>designating the vehicle so licensed as belonging to a person who</u>
- 16 <u>is a recipient of the Silver Star. The special registration</u>
- 17 plate may be used only on a passenger car or truck with a
- 18 registered gross weight of not more than 10,000 pounds.

- 1 § 1367. Special plates for recipients of Bronze Star.
- 2 <u>Upon application of any person who is a recipient of the</u>
- 3 Bronze Star, accompanied by a fee of \$20 which shall be in
- 4 <u>addition to the annual registration fee and by such</u>
- 5 <u>documentation as the department shall require</u>, the department
- 6 shall issue to the person a special registration plate
- 7 <u>designating the vehicle so licensed as belonging to a person who</u>
- 8 is a recipient of the Bronze Star. The special registration
- 9 plate may be used only on a passenger car or truck with a
- 10 registered gross weight of not more than 10,000 pounds.
- 11 § 1368. Special plates for recipients of Bronze Star with
- 12 <u>Valor.</u>
- 13 Upon application of any person who is a recipient of the
- 14 Bronze Star for Valor, accompanied by a fee of \$10 \$20 which
- 15 shall be in addition to the annual registration fee and by such
- 16 documentation as the department shall require, the department
- 17 shall issue to the person a special registration plate
- 18 designating the vehicle so licensed as belonging to a person who
- 19 is a recipient of the Bronze Star for Valor. The special
- 20 registration plate may be used only on a passenger car or truck
- 21 with a registered gross weight of not more than 10,000 pounds.
- 22 Section 2. This act shall take effect in 120 days.
