INTRODUCED BY CORMAN, JUNE 8, 2011

AS REPORTED FROM COMMITTEE ON APPROPRIATIONS, HOUSE OF REPRESENTATIVES, AS AMENDED, JUNE 21, 2012

AN ACT

1 Making appropriations to the Trustees of the University of  
2 Pennsylvania.

3 The General Assembly of the Commonwealth of Pennsylvania  
4 hereby enacts as follows:

5 Section 1. (a) The sum of \$27,889,000, or as much thereof  
6 as may be necessary, is hereby appropriated to the Trustees of  
7 the University of Pennsylvania for the fiscal year ~~July 1, 2011,~~ ←  
8 ~~to June 30, 2012~~ JULY 1, 2012, TO JUNE 30, 2013, for veterinary ←  
9 activities.

10 (b) The sum of \$248,000, or as much thereof as may be  
11 necessary, is hereby appropriated to the Trustees of the  
12 University of Pennsylvania for the fiscal year ~~July 1, 2011, to~~ ←  
13 ~~June 30, 2012~~ JULY 1, 2012, TO JUNE 30, 2013, for the Center for ←  
14 Infectious Diseases.

15 Section 2. (a) Payments to the University of Pennsylvania  
16 on account of the appropriations shall be made quarterly by the  
17 Secretary of Agriculture on the basis of costs during the fiscal

1 year and shall be conditioned on continuing authority for  
2 inclusion on the Board of Trustees of the University of  
3 Pennsylvania of a minimum of four persons who are not elected  
4 officials and who are appointed by the President pro tempore of  
5 the Senate, the Minority Leader of the Senate, the Speaker of  
6 the House of Representatives and the Minority Leader of the  
7 House of Representatives for terms of office coterminous with  
8 that of the respective appointing authority; and shall be  
9 further conditioned on these appointees receiving full voting  
10 rights as members of the board of trustees.

11 (b) The University of Pennsylvania shall provide full,  
12 complete and accurate information as may be required by the  
13 Department of Agriculture or the chairman or the minority  
14 chairman of the Appropriations Committee of the Senate or the  
15 chairman or the minority chairman of the Appropriations  
16 Committee of the House of Representatives.

17 (c) The University of Pennsylvania shall report its revenues  
18 and expenditures and present its financial statements in  
19 accordance with generally accepted accounting principles and  
20 procedures for educational institutions as set forth in the  
21 "Higher Education Finance Manual (1975)" and the "Commonwealth  
22 of Pennsylvania Budget Instructions for the State System of  
23 Higher Education, State-Related Universities and Non-State-  
24 Related Colleges and Universities."

25 (d) The Trustees of the University of Pennsylvania shall  
26 report on forms provided by the Department of Agriculture to  
27 both the chairman and minority chairman of the Appropriations  
28 Committee of the Senate and the chairman and minority chairman  
29 of the Appropriations Committee of the House of Representatives  
30 by September 30, ~~2012~~ 2013, on how State-appropriated funds were



1 expended for fiscal year ~~2011-2012~~ 2012-2013 to reduce the costs ←  
2 to Pennsylvania resident students or to provide services to  
3 Pennsylvania residents.

4 Section 3. This act shall take effect July 1, ~~2011~~ 2012, or ←  
5 immediately, whichever is later.
