A RESOLUTION

- Directing the Legislative Budget and Finance Committee to conduct a study of the museums in this Commonwealth and research and evaluate how funding and resources are allocated for this Commonwealth's museums.
- 5 WHEREAS, This Commonwealth's museums are vital players in the
- 6 economic and social prosperity of this Commonwealth; and
- 7 WHEREAS, This Commonwealth's museums provide valuable
- 8 educational experience to citizens of all ages; and
- 9 WHEREAS, This Commonwealth's museums provide significant
- 10 economic impact and tourism dollars; and
- 11 WHEREAS, This Commonwealth's museums help preserve the long
- 12 history of Pennsylvania, this nation and the world; and
- 13 WHEREAS, This Commonwealth's museums help educate young and
- 14 old alike on a variety of subjects from fine art to Pennsylvania
- 15 history to sports history; and
- 16 WHEREAS, This Commonwealth's museums are a low-cost, family
- 17 friendly cultural attraction; and
- 18 WHEREAS, The Federal Government defines a museum as "a public

- 1 or private nonprofit agency or institution organized on a
- 2 permanent basis for essentially education or aesthetic purposes,
- 3 which, utilizing a professional staff, owns or utilizes tangible
- 4 objects, cares for them, and exhibits them on a regular basis";
- 5 and
- 6 WHEREAS, The Commonwealth funds its museums in a variety of
- 7 ways including the Museum Assistance Grants, Nonpreferred
- 8 Appropriations and individual line items within the State
- 9 operating budget; and
- 10 WHEREAS, There has been a decline in State funding to this
- 11 Commonwealth's museums in recent years; and
- 12 WHEREAS, The unpredictable and varied funding for this
- 13 Commonwealth's museums has been a burden to many of the museums;
- 14 and
- 15 WHEREAS, The temporary or permanent loss of any of this
- 16 Commonwealth's museums due to a decline in State funding will
- 17 impact the economic and cultural climate of its surrounding
- 18 community; therefore be it
- 19 RESOLVED, That the Legislative Budget and Finance Committee
- 20 conduct a study of this Commonwealth's museums, measuring
- 21 funding and resources allocated to the museums; and be it
- 22 further
- 23 RESOLVED, That the study should include an analysis of the
- 24 current museum funding; and be it further
- 25 RESOLVED, That the Legislative Budget and Finance Committee
- 26 provide recommendations necessary or desirable to improve the
- 27 funding of this Commonwealth's valued museums; and be it further
- 28 RESOLVED, That the Legislative Budget and Finance Committee
- 29 report to the Senate the result of its study and recommendations
- 30 regarding the status of funding of this Commonwealth's museums

- 1 and file the report with the Chief Clerk of the Senate no later
- 2 than 90 days after adoption of this resolution.
