- Amending Title TITLES 18 (Crimes and Offenses) AND 42 (JUDICIARY <--AND JUDICIAL PROCEDURE) of the Pennsylvania Consolidated Statutes, IN SEXUAL OFFENSES, providing for the offense of sexual assault by sports official, volunteer or employee of nonprofit association; AND, IN SENTENCING, FURTHER PROVIDING <--FOR SENTENCES FOR OFFENSES AGAINST INFANT PERSONS. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. Title 18 of the Pennsylvania Consolidated 10 Statutes is amended by adding a section to read: § 3124.3. Sexual assault by sports official, volunteer or 11 12 employee of nonprofit association. 13 (a) Sports official. -- Except as provided in section 3121 (relating to rape), 3122.1 (relating to statutory sexual assault), 3123 (relating to involuntary deviate sexual 15 intercourse), 3124.1 (relating to sexual assault) and 3125 16
- 17 <u>(relating to aggravated indecent assault)</u>, a person who serves

- 1 <u>as a sports official in a sports program of a nonprofit</u>
- 2 <u>association or a for-profit association commits a felony of the</u>
- 3 third degree when that person engages in sexual intercourse,
- 4 <u>deviate sexual intercourse or indecent contact with a child</u>
- 5 under 18 years of age who is participating in a sports program
- 6 of the nonprofit association or for-profit association.
- 7 (b) Volunteer or employee of nonprofit association. -- Except
- 8 <u>as provided in sections 3121, 3122.1, 3123, 3124.1 and 3125, a</u>
- 9 <u>volunteer or an employee of a nonprofit association having</u>
- 10 direct contact with a child under 18 years of age who
- 11 participates in a program or activity of the nonprofit
- 12 association commits a felony of the third degree if the
- 13 <u>volunteer or employee engages in sexual intercourse, deviate</u>
- 14 <u>sexual intercourse or indecent contact with that child.</u>
- 15 <u>(c) Definitions.--As used in this section, the following</u>
- 16 words and phrases shall have the meanings given to them in this
- 17 subsection unless the context clearly indicates otherwise:
- 18 "Direct contact." Care, supervision, quidance or control.
- 19 "Nonprofit association." As defined in 42 Pa.C.S. § 8332.1
- 20 (relating to manager, coach, umpire or referee and nonprofit
- 21 association negligence standard).
- 22 "Sports official." A person who supervises children
- 23 participating in a sports program of a nonprofit association or
- 24 <u>a for-profit association, including, but not limited to, a</u>
- 25 coach, assistant coach, athletic trainer, team attendant, game
- 26 manager, instructor or a person at a sports program who enforces
- 27 the rules of a sporting event sponsored by a sports program of a
- 28 nonprofit association or a for-profit association, including,
- 29 <u>but not limited to, an umpire or referee, whether receiving</u>
- 30 remuneration or holding the position as a volunteer.

- 5 § 9718. SENTENCES FOR OFFENSES AGAINST INFANT PERSONS.
- 6 (A) MANDATORY SENTENCE.--
- 7 (1) A PERSON CONVICTED OF THE FOLLOWING OFFENSES WHEN
- 8 THE VICTIM IS [UNDER] LESS THAN 16 YEARS OF AGE SHALL BE
- 9 SENTENCED TO A MANDATORY TERM OF IMPRISONMENT AS FOLLOWS:
- 10 18 PA.C.S. § 2702(A)(1) AND (4) (RELATING TO AGGRAVATED
- 11 ASSAULT) NOT LESS THAN TWO YEARS.
- 12 18 PA.C.S. § 3121(A)(1), (2), (3), (4) AND (5) (RELATING
- 13 TO RAPE) NOT LESS THAN TEN YEARS.
- 14 18 PA.C.S. § 3123 (RELATING TO INVOLUNTARY DEVIATE SEXUAL
- 15 INTERCOURSE) NOT LESS THAN TEN YEARS.
- 16 18 PA.C.S. § 3125(A)(1) THROUGH (6) (RELATING TO
- 17 AGGRAVATED INDECENT ASSAULT) NOT LESS THAN FIVE YEARS.
- 18 (2) A PERSON CONVICTED OF THE FOLLOWING OFFENSES WHEN
- 19 THE VICTIM IS LESS THAN 13 YEARS OF AGE SHALL BE SENTENCED TO
- 20 A MANDATORY TERM OF IMPRISONMENT AS FOLLOWS:

- 22 <u>15 YEARS.</u>
- 24 (3) A PERSON CONVICTED OF THE FOLLOWING OFFENSES SHALL
- 25 BE SENTENCED TO A MANDATORY TERM OF IMPRISONMENT AS FOLLOWS:
