17 (c) Terms of office and compensation.--The members shall

hold office for terms of [eight] four years and until a 1 2 successor is appointed and qualified. [A member appointed to 3 fill a vacancy for a period of four years or less may be eligible for appointment to a full eight-year term. A member who 4 5 serves a full eight-year term or fills a vacancy for a period of 6 more than four years shall not be eligible for reappointment to the commission until a period of eight years expires.] The 7 8 members shall receive no compensation for their services but may 9 be reimbursed for travel expenses. When performing any function 10 on behalf of the commission or acting within the scope of their 11 official duties, members of the commission shall be authorized 12 to operate Commonwealth vehicles and watercraft and shall be 13 treated as employees of the Commonwealth for the purposes of 14 automotive and general liability and the act of June 2, 1915 15 (P.L.736, No.338), known as the Workers' Compensation Act. * * * 16

17 SECTION 2. THE FOLLOWING SHALL APPLY:

18 (1) EXCEPT AS PROVIDED UNDER PARAGRAPH (2), THE
19 AMENDMENT OF 30 PA.C.S. § 301(A) AND (C) SHALL APPLY TO
20 MEMBERS OF THE PENNSYLVANIA FISH AND BOAT COMMISSION WHO ARE
21 APPOINTED ON OR AFTER THE EFFECTIVE DATE OF THIS SECTION.

(2) NOTWITHSTANDING PARAGRAPH (1), A MEMBER OF THE
PENNSYLVANIA FISH AND BOAT COMMISSION WHO SERVES A FULL
EIGHT-YEAR TERM OR FILLS A VACANCY FOR A PERIOD OF MORE THAN
FOUR YEARS SHALL BE ELIGIBLE FOR REAPPOINTMENT TO THE
COMMISSION AT ANY TIME.
