AN ACT

- Establishing the Pennsylvania Community College Affordability
 Task Force within the Department of Education; and providing
 for its powers and duties and for administrative support.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Pennsylvania Community College Affordability Task
- 7 Force.
- 8 (a) Establishment.--There is established within the
- 9 Department of Education a task force on the affordability of
- 10 community college education.
- 11 (b) Composition. -- The task force shall be composed of the
- 12 following members:
- 13 (1) The Secretary of Education, who shall act as
- 14 chairperson of the task force.
- 15 (2) Six representatives of community colleges, including
- four college presidents and two members of boards of trustees

- of community colleges to be appointed by the Pennsylvania
 Commission for Community Colleges.
 - (3) Two members of the Senate to be appointed by the President pro tempore of the Senate.
 - (4) Two members of the House of Representatives to be appointed by the Speaker of the House of Representatives.
 - (5) One county commissioner that represents a county that sponsors a local community college as appointed by the Secretary of Education.
- 10 (6) One member of a school board that sponsors a local
 11 community college as appointed by the Secretary of Education.
- 12 (7) Two representatives to be appointed by the Governor 13 who are members of the business community.
- 14 (8) Two students attending community colleges as
 15 appointed by the Pennsylvania Commission for Community
 16 Colleges.
- 17 (9) Two faculty members employed by community colleges
 18 as appointed by the Pennsylvania Commission for Community
 19 Colleges.
- 20 (c) Study. -- The task force shall examine and make
- 21 recommendations regarding the viability and sustainability of
- 22 the current community college funding model, accessibility of
- 23 community college services across this Commonwealth, and the
- 24 long-term affordability and accessibility of a community college
- 25 education for residents of this Commonwealth. The task force
- 26 should also consider the various components of the community
- 27 college mission, including open access and workforce
- 28 development.

- 29 (d) Report to the General Assembly. -- The task force shall
- 30 issue a report of its findings and recommendations to the

- 1 Governor, the President pro tempore of the Senate, the Speaker
- 2 of the House of Representatives, the Minority Leader of the
- 3 Senate, the Minority Leader of the House of Representatives, the
- 4 chair and minority chair of the Education Committee of the
- 5 Senate and the chair and minority chair of the Education
- 6 Committee of the House of Representatives. This report shall be
- 7 submitted within 180 days after the first meeting of the task
- 8 force.
- 9 (e) Meetings.--The task force shall meet as deemed necessary
- 10 by the chair in order to carry out the study and make
- 11 recommendations.
- 12 (f) Compensation.--Task force members shall receive no
- 13 compensation for their services but shall be reimbursed for all
- 14 necessary travel and other reasonable expenses incurred in
- 15 connection with the performance of their duties as members.
- 16 (q) Duties of department. -- The Department of Education shall
- 17 provide administrative support, office space and any other
- 18 technical assistance required by the task force to carry out its
- 19 duties under this section.
- 20 Section 2. Effective date.
- 21 This act shall take effect immediately.
