AN ACT

1 Amending Title 42 (Judiciary and Judicial Procedure) of the
2 Pennsylvania Consolidated Statutes, IN FACILITIES AND <--
3 SUPPLIES RELATING TO JUDICIAL COMPUTER SYSTEM, further
4 providing for surcharge ~~for deposit into the Access to~~ <--
5 ~~Justice Account.~~

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Section 3733.1(a) and (c) of Title 42 of the
9 Pennsylvania Consolidated Statutes are amended to read:

10 § 3733.1. Surcharge.

11 (a) Imposition of surcharge.--In addition to each fee
12 imposed under section 3733(a.1) (relating to deposits into
13 account), except as set forth in subsection (b), the following
14 apply:

15 (1) A surcharge of ~~+\$11.25~~ \$10.25 shall be charged and <--
16 collected. This paragraph shall expire December 31, [2014] <--
17 2017.

1 (2) A permanent fee of \$2.25 shall be charged and
2 collected.

3 (3) A permanent fee of \$2 shall be charged and
4 collected.

6 (c) Allocation and appropriation.--

7 (1) The surcharge under subsection (a)(1) [shall be
8 allocated as follows:

9 (i) One dollar shall be deposited into the Access to
10 Justice Account.

11 (ii) The remainder of money] shall be deposited into
12 a separate reserve account within the Judicial Computer
13 System Augmentation Account. Notwithstanding section 3732
14 (relating to utilization of funds in account), money
15 deposited under this [subparagraph] paragraph is hereby
16 appropriated to the Supreme Court, upon compliance with
17 Article XV of the act of April 9, 1929 (P.L.343, No.176),
18 known as The Fiscal Code, for the operation of the
19 Judicial Department.

20 (2) The fee under subsection (a)(2) shall be deposited
21 into the Criminal Justice Enhancement Account.

22 (3) The fee under subsection (a)(3) shall be deposited
23 into the Access to Justice Account.

24 Section 2. This act shall take effect in 30 days.
