## AN ACT

- Designating the interchange of US Route 119 and US Route 22 in Burrell Township, Indiana County, as the Staff Sergeant Glen
- 3 H. Stivison, Jr., Memorial Interchange.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Staff Sergeant Glen H. Stivison, Jr., Memorial
- 7 Interchange.
- 8 (a) Findings.--
- 9 (1) Staff Sergeant Glen H. Stivison, Jr., an honored and
- decorated soldier, was born on May 10, 1975, in Homer City,
- 11 Pennsylvania, and graduated from Blairsville High School,
- where he lettered in football and wrestling.
- 13 (2) Staff Sergeant Stivison enlisted in the United
- 14 States Army in September 1996 and completed training as a

- 1 combat engineer.
- 2 (3) Staff Sergeant Stivison proudly served his country 3 in Korea, Kuwait, Iraq and Afghanistan.
- 4 (4) On October 15, 2009, Staff Sergeant Stivison made
  5 the ultimate sacrifice while leading a rescue mission near
  6 the Kandahar River Bridge in the Kandahar region of
  7 Afghanistan when the vehicle he was commanding was struck by
  8 an improvised explosive device. HE WAS POSTHUMOUSLY AWARDED A <--
- 9 BRONZE STAR AND PURPLE HEART MEDAL.
- 10 (5) Staff Sergeant Stivison is survived by his wife, the 11 former Eryn Leaver, sons, William and Andrew Stivison,
- 12 parents Glen and Jan Stivison, and three brothers TWO <--
- BROTHERS, BILL AND BEN STIVISON, AND ONE SISTER, CAREY
- 14 STIVISON HARPER.
- 15 (b) Designation. -- The interchange of US Route 119 and US
- 16 Route 22 in Burrell Township, Indiana County, is hereby
- 17 designated the Staff Sergeant Glen H. Stivison, Jr., Memorial
- 18 Interchange.
- 19 (c) Signs. -- The Department of Transportation shall erect and
- 20 maintain appropriate signs to indicate the designation of this
- 21 section.
- 22 Section 2. Effective date.
- 23 This act shall take effect immediately.
