14	or taxed as real estate regardless of whether the structure
15	has become affixed to the real estate, when the structure is
16	constructed consistent with all of the following:
17	(i) has a metal, wood or plastic frame;

3	(iii) has a floor made of soil, crushed stone,	
4	matting, pavers or a floating concrete slab.
