AN ACT

- 1 Relating to agreements among governmental units for the
- operation of payment offsets; and imposing duties on the
- 3 State Treasurer.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Inter-
- 8 Governmental Payment Offset Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Commonwealth agency." Any of the following:
- (1) An office, department, authority, board, multistate
- agency or commission of the executive branch, an independent
- 16 agency and a State-affiliated entity. The term includes:
- 17 (i) The Governor's Office.
- 18 (ii) The Office of Attorney General, the Department

- of the Auditor General and the Treasury Department.
- 2 (iii) An organization established by the
- 3 Constitution of Pennsylvania, a statute or an executive
- 4 order which performs or is intended to perform an
- 5 essential governmental function.
- 6 (2) The term does not include a judicial or legislative
- 7 agency.
- 8 "Department." The Department of Revenue of the Commonwealth.
- 9 Section 3. Payment offset agreement between the Commonwealth
- 10 and Federal Government.
- 11 (a) Authorization. -- The department is authorized to enter
- 12 into an agreement with the United States to participate in the
- 13 Treasury Offset Program under 31 U.S.C. § 3716 (relating to
- 14 administrative offset) for the collection of debts owed to a
- 15 Commonwealth agency. The agreement may provide for the Federal
- 16 Government to submit debts owed to a Federal agency for offset
- 17 against Commonwealth and political subdivision payments and
- 18 provide for the Commonwealth to submit debts owed to a
- 19 Commonwealth agency or a political subdivision for offset
- 20 against Federal payments.
- 21 (b) Commonwealth payment.--The State Treasurer shall reduce
- 22 a Commonwealth payment by the amount of a Federal debt submitted
- 23 in accordance with the agreement authorized by this section and
- 24 pay the amount to the appropriate Federal official in accordance
- 25 with the procedures specified in the agreement.
- 26 (c) Political subdivision payment. -- The appropriate official
- 27 of a political subdivision shall reduce a political subdivision
- 28 payment by the amount of a Federal debt submitted in accordance
- 29 with the agreement authorized by this section and pay the amount
- 30 to the appropriate Federal official in accordance with the

- 1 procedures specified in the agreement.
- 2 Section 4. Payment offset agreement between the Commonwealth
- and a political subdivision.
- 4 (a) Authorization. -- The department is authorized to enter
- 5 into an administrative offset agreement with a political
- 6 subdivision for the collection of debts owed to a Commonwealth
- 7 agency. The agreement may provide for the political subdivision
- 8 to submit debts owed to the political subdivision for offset
- 9 against Commonwealth payments and provide for the Commonwealth
- 10 to submit debts owed to Commonwealth agencies for offset against
- 11 political subdivision payments.
- 12 (b) Commonwealth payment. -- The State Treasurer shall reduce
- 13 a Commonwealth payment by the amount of a political subdivision
- 14 debt submitted in accordance with the agreement authorized by
- 15 this section and pay the amount to the appropriate political
- 16 subdivision official in accordance with the procedures specified
- 17 in the agreement.
- 18 (c) Political subdivision payment. -- The appropriate official
- 19 of a political subdivision shall reduce a political subdivision
- 20 payment by the amount of a Commonwealth debt submitted in
- 21 accordance with the agreement authorized by this section and pay
- 22 the amount to the State Treasurer in accordance with the
- 23 procedures specified in the agreement.
- 24 Section 5. Payment offset agreement between the Commonwealth
- and another state.
- 26 (a) Authorization. -- The department is authorized to enter
- 27 into an administrative offset agreement with another state for
- 28 the collection of debts owed to a Commonwealth agency. The
- 29 agreement may provide for the other state to submit debts owed
- 30 the state for offset against Commonwealth payments and provide

- 1 for the Commonwealth to submit debts owed to a Commonwealth
- 2 agency for offset against state payments.
- 3 (b) Commonwealth payment. -- The State Treasurer shall reduce
- 4 a Commonwealth payment by the amount of a debt of another state
- 5 submitted in accordance with the agreement authorized by this
- 6 section and pay the amount to the appropriate official in the
- 7 other state in accordance with the procedures specified in the
- 8 agreement.
- 9 (c) Payment by another state. -- An agreement under this
- 10 section must require the appropriate official of another state
- 11 to reduce a payment of the other state by the amount of a
- 12 Commonwealth debt submitted in accordance with the agreement
- 13 authorized by this section and pay the amount to the State
- 14 Treasurer in accordance with the procedures specified in the
- 15 agreement.
- 16 Section 20. Effective date.
- 17 This act shall take effect in immediately.
