- 2 act empowering the Department of Community [Affairs] and

- Section 2. Section 102 of the act, amended Oct. 20, 2011
- 16 (P.L.318, No.79), is amended to read:
- 17 Section 102. Purpose and legislative intent.
- 18 (a) Policy.--It is hereby declared to be a public policy of
- 19 the Commonwealth to foster fiscal integrity of municipalities so
- 20 that they provide for the health, safety and welfare of their
- 21 citizens; pay principal and interest on their debt obligations
- 22 when due; meet financial obligations to their employees, vendors
- 23 and suppliers; and provide for proper financial accounting
- 24 procedures, budgeting and taxing practices. The failure of a
- 25 municipality to do so is hereby determined to affect adversely
- 26 the health, safety and welfare not only of the citizens of the
- 27 municipality but also of other citizens in this Commonwealth.
- 28 (b) Legislative intent. -- The General Assembly finds and
- 29 declares as follows:
- 30 (1) It is the intent of the General Assembly to:

1 (i) Enact procedures to provide municipalities showing early indicators of financial distress with 2 training and technical and financial assistance. 3 [(i)] (ii) Enact procedures and provide powers and 4 5 guidelines to ensure fiscal integrity of municipalities while leaving principal responsibility for conducting the 6 7 governmental affairs of a municipality, including 8 choosing the priorities for and manner of expenditures 9 based on available revenues, to the charge of its elected 10 officials, consistent with the public policy set forth in this section. 11 12 [(ii)] (iii) Enact procedures for the adjustment of 13 municipal debt by negotiated agreement with creditors. 14 [(iii)] (iv) Provide for the exercise of the 15 Commonwealth's sovereign and plenary police power in 16 emergency fiscal conditions to protect the health, safety 17 and welfare of a municipality's citizens when local 18 officials are unwilling or unable to accept a solvency 19 plan developed for the benefit of the [community] 20 municipality. 21 (v) Provide for the exercise of the Commonwealth's 22 sovereign and plenary power to establish and abolish 23 local government units and provide essential services in 24 areas of this Commonwealth in which the fiscal integrity

- of existing local government units cannot be sustained.
- Changing and deteriorating economic conditions, developing technologies and attendant unemployment erode local tax bases and threaten essential municipal services. Under such circumstances, such distressed governmental units may no longer be viable and that the citizens of those

communities should be granted the opportunity <u>in accordance</u>

2 with law to voluntarily consolidate or merge their

3 municipalities with other municipalities in an effort to

4 allow municipal boundaries to reflect the geographic and

5 economic realities of a distressed area, to merge a common

6 community of interest, to take advantage of economies of

7 scale in providing services and to create an expanded revenue

base to provide necessary public services to the citizens of

financially distressed municipalities.

- (3) Policies of certain municipalities are so ineffective and the financial conditions so severe that the provision of vital and necessary services is threatened.
- (4) Sustained failure of a municipality to enact or implement a fiscal plan to adequately address or prevent insolvency after repeated opportunities to do so:
 - (i) constitutes a fiscal emergency; and

- 18 (A) a breakdown in the function of municipal government;
 - (B) a dereliction of its elected officials'

 paramount public duty to safeguard the health, safety

 and welfare of its citizens; and
- 23 (C) a threat to the fiscal stability of neighboring communities.
- 25 (5) Pursuant to the Commonwealth's paramount right and
 26 duty to maintain law and order and protect and preserve the
 27 health, safety and welfare of its citizens and ensure
 28 compliance with this act under Article IX of the Constitution
 29 of Pennsylvania, the Governor is authorized to act in the
 30 face of a fiscal emergency under paragraph (4)(i) and

- dereliction of official duty under paragraph (4)(ii)(B).
- 2 (6) Municipalities may face such deteriorated economic
- 3 conditions that all reasonable efforts to restore economic
- 4 <u>viability have failed and merger or consolidation cannot</u>
- 5 occur through any means provided by law. It is the intent of
- 6 the General Assembly that, for municipalities incapable of
- 7 <u>continuing to function as general purpose units of local</u>
- 8 government, procedures exist to ensure the provision of
- 9 essential and vital public services to the residents of those
- 10 areas absent a functioning municipal government.
- 11 Section 3. Section 103 of the act, repealed Oct. 13, 1994
- 12 (P.L.596, No.90) and added July 5, 2012 (P.L.1104, No.133), is

- 14 Section 103. Definitions.
- The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 "Arbitration settlement." An adjustment or settlement of a
- 19 collective bargaining agreement or dispute. The term includes a
- 20 final or binding arbitration award or other determination.
- 21 "Authority." A municipal authority, parking authority or any
- 22 other authority or corporate entity that is directly or
- 23 indirectly controlled by a distressed municipality or to which a
- 24 distressed municipality has power of appointment.
- 25 "Basis of accounting." Revenues and expenditures may be
- 26 recognized on the cash, modified accrual or full accrual basis
- 27 of accounting, provided that basis is applied consistently
- 28 throughout the fiscal periods reported for evaluation purposes.
- "Chief executive officer." Mayor in a mayor-council form of
- 30 government or manager in a council-manager form of government of

- 1 a city operating under an optional form of government pursuant
- 2 to the act of July 15, 1957 (P.L.901, No.399), known as the
- 3 Optional Third Class City Charter Law; a mayor of a city of the
- 4 first class under the act of April 21, 1949 (P.L.665, No.155),
- 5 known as the First Class City Home Rule Act; or an individual
- 6 serving in such capacity as designated by a home rule charter or
- 7 optional plan pursuant to the act of April 13, 1972 (P.L.184,
- 8 No.62), known as the Home Rule Charter and Optional Plans Law.
- 9 "Claim." Right to payment, whether or not the right is
- 10 reduced to judgment, liquidated, unliquidated, fixed,
- 11 contingent, matured, unmatured, disputed, undisputed, legal,
- 12 equitable, secured or unsecured; or right to an equitable remedy
- 13 for breach of performance if the breach gives rise to a right to
- 14 payment, whether or not the right to an equitable remedy is
- 15 reduced to judgment, fixed, contingent, matured, unmatured,
- 16 disputed, undisputed, secured or unsecured.
- "Commonwealth agency." The Governor and the departments,
- 18 boards, commissions, authorities and other officers and agencies
- 19 of this Commonwealth, whether or not subject to the policy
- 20 supervision and control of the Governor.
- 21 "Creditor." An individual, partnership, corporation,
- 22 association, estate, trust, governmental unit or the governing
- 23 board of a pension fund of a municipality that has a claim
- 24 against a municipality.
- 25 "Deficit." The excess of expenditures over revenues, stated
- 26 as a percentage of revenue, during an accounting period. This
- 27 calculation shall include all governmental fund types and all
- 28 proprietary fund types, but shall exclude all fiduciary fund
- 29 types of the municipality.
- 30 "Department." The Department of Community [Affairs] and

- 1 <u>Economic Development</u> of the Commonwealth.
- 2 "Expenditures." Reductions in fund equity, including current
- 3 operating expenses that require the use of fund equity, debt
- 4 service and capital outlays. The term shall not include
- 5 interfund transfers.
- 6 "Fund equity." Excess of assets of a fund over its
- 7 liabilities.
- 8 "Governing body." The council in cities, boroughs and
- 9 incorporated towns; the board of commissioners in counties; the
- 10 board of commissioners in townships of the first class; the
- 11 board of supervisors in townships of the second class; or the
- 12 legislative policy-making body in home rule municipalities.
- 13 "Matured claim." A claim that has been reduced to judgment
- 14 or liquidated in amount by agreement for a period of 90 days
- 15 prior to the filing of a petition to commence fiscal distress
- 16 proceedings under this act.
- "Municipal record." A financial record [and] or document of
- 18 a municipality or of [an authority incorporated by a
- 19 municipality, excluding confidential] an authority or other_
- 20 corporate entity which directly or indirectly performs a
- 21 governmental function on behalf of the municipality, is directly
- 22 <u>or indirectly controlled by the municipality or to which the</u>
- 23 municipality has direct or indirect power of appointment or has
- 24 directly or indirectly pledged or designated the municipality's
- 25 revenues or the municipality's credit. The term does not
- 26 include:
- 27 <u>(1) Confidential</u> information relating to personnel
- 28 matters and matters relating to the initiation and conduct of
- investigations of violations of law. To the extent such
- information is included in a financial record or document

- 1 <u>otherwise subject to this definition, it shall be redacted</u>
- 2 and the remainder subject to disclosure as otherwise provided
- 3 <u>by this act.</u>
- 4 (2) A financial record or document in the custody or
- 5 <u>control of an entity other than a municipality, municipal</u>
- 6 <u>authority or other authority, except if the document relates</u>
- 7 <u>to services or governmental functions performed by the</u>
- 8 <u>municipality</u>, <u>municipal authority or on behalf of the</u>
- 9 municipality or municipal authority, or the revenues or
- 10 credit of the municipality or a municipal authority.
- "Municipality." Every county, city, borough, incorporated
- 12 town, township and home rule municipality.
- "Plan" or "recovery plan." A recovery plan developed under
- 14 this act.
- 15 "Revenues." Additions to fund equity other than from
- 16 interfund transfers, proceeds of debt and proceeds of
- 17 disposition of general fixed assets.
- "Secretary." The Secretary of Community [Affairs] and
- 19 <u>Economic Development</u> of the Commonwealth.
- 20 Section 4. Section 121(a), (b) and (c) of the act are
- 21 amended to read:
- 22 Section 121. Powers and duties of department.
- 23 (a) Compile financial data.--
- 24 (1) A power and duty of the department shall be to
- 25 maintain accurate and current information and data on the
- 26 fiscal status of municipalities to determine if criteria set
- forth in section 201 exist and, if so, whether the existence
- of those factors validly indicates fiscal distress.
- 29 (2) In compiling the information and data, the
- department shall mail, before January 1 of each year, a

- Survey of Financial Condition form to each municipality applicable to the municipality's prior fiscal year.
 - (i) The survey shall seek information necessary to determine the fiscal status of a municipality, shall be concise to facilitate prompt response and shall contain an attestation clause to be signed by the presiding officer of the municipality's governing body. [The actual survey form shall not exceed two pages in length.]
 - (ii) The survey shall be provided to the municipal clerk or municipal secretary along with tax information forms in accordance with law.
- 12 (iii) The survey shall include information based on 13 the criteria specified in section 201.
- 14 (iv) The survey shall include information relating 15 to the basis of accounting utilized by municipalities.
- 16 (b) Assess data.--A power and duty of the department shall
- 17 be to apply the criteria of section 201 to data and information
- 18 on the fiscal status of municipalities to assess the validity
- 19 and applicability of an indication of municipal financial
- 20 distress. In assessing validity and applicability, the
- 21 department shall undertake a review process, including, but not
- 22 limited to, consultation, correspondence and visits with a
- 23 municipality which appears to be financially distressed,
- 24 notwithstanding the provisions of section 2501-C(e) and (f) of
- 25 the act of April 9, 1929 (P.L.177, No.175), known as The
- 26 Administrative Code of 1929, which limits department
- 27 intervention to incidences when such is requested by the
- 28 municipality. If the department [assesses] determines that a
- 29 municipality needs assistance to correct minor fiscal problems,
- 30 the department shall offer appropriate recommendations,

- 1 <u>including a recommendation that the municipality submit an</u>
- 2 application as provided in Chapter 1-A. If the municipality
- 3 adopts those recommendations, the department need take no

- 5 (c) Notify agencies of determination. -- Upon the making of a
- 6 determination by the secretary that a municipality is distressed
- 7 pursuant to section 203(f), the department shall immediately
- 8 notify the heads of all Commonwealth agencies of the
- 9 determination. The department shall, by January 1 of each year
- 10 thereafter, notify the heads of all Commonwealth agencies of the
- 11 priority funding requirement for distressed municipalities as
- 12 provided in section 282.

- 14 Section 5. Section 122 of the act is amended by adding a
- 15 subsection to read:
- 16 Section 122. Duties of Commonwealth agencies.

- 18 (c) Waiver of certain administrative mandates.--
- 19 (1) Notwithstanding any provision of law and at the
- request of the coordinator or receiver, a Commonwealth agency
- 21 may exempt a distressed municipality from the application of
- 22 a regulatory requirement, if the following conditions are
- 23 satisfied:
- (i) The regulatory requirement is not expressly
- required by Federal law or regulation, or an act of the
- 26 Commonwealth, and is not related to the rights or terms
- 27 <u>and conditions of employment by the municipality.</u>
- 28 (ii) The waiver of the regulatory mandate will not
- 29 likely affect public health and safety.
- 30 (2) It is the intent of this subsection that distressed

- 1 <u>municipalities be considered for relief from regulatory</u>
- 2 mandates that, due to financial distress or the
- implementation of recovery measures, are unduly burdensome on
- 4 <u>the municipality and would not undermine the regulatory</u>
- 5 <u>purposes of the agency if waived.</u>
- 6 Section 6. Sections 123 and 141 of the act, amended July 11,
- 7 1996 (P.L.645, No.108), are amended to read:
- 8 Section 123. Powers and duties of municipalities.
- 9 (a) File completed survey. -- On or before March 15 of each
- 10 year, every municipality shall return to the department a
- 11 completed Survey of Financial Conditions referred to in section
- 12 121(a). No municipality shall receive its alloted payments
- 13 pursuant to the act of June 1, 1956 (1955 P.L.1944, No.655),
- 14 referred to as the Liquid Fuels Tax Municipal Allocation Law,
- 15 unless it complies with the provisions of this section,
- 16 notwithstanding a provision of law to the contrary, including
- 17 any provisions which require payment prior to March 15, and the
- 18 Department of Transportation may not disburse funds to a
- 19 municipality pursuant to the Liquid Fuels Tax Municipal

- by the courts or a tax is approved as provided in subsection (d), the increase shall be effective for a period of one year. - 21 (a) Authority to assess. -- The administrator may establish
- 22 assessments on a front foot or benefit-conferred basis, or a
- 23 combination of both, on all real property within the district to

- 25 (1) The cost of all essential services provided to the
- 26 district.
- 27 (2) The service of all debts held in trust by the
