## AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- Consolidated Statutes, further providing for the pay of officers and enlisted personnel in active State service.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3102 of Title 51 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- $8\$  § 3102. Pay of officers and enlisted personnel in active State
- 9 service.
- 10 (a) General rule. -- When the Pennsylvania National Guard or
- 11 Pennsylvania Guard, or any part thereof, is ordered on active
- 12 duty for State service by the Governor as Commander-in-Chief and
- 13 pay is authorized for such duty under the order prescribing the
- 14 performance thereof, the commissioned officers, warrant officers
- 15 and enlisted personnel so ordered shall be entitled to the same

- 1 pay and allowances and transportation in kind provided for in
- 2 the current Armed Forces Pay and Allowance Act. Notwithstanding
- 3 any provisions of such act, the pay of any such personnel shall
- 4 not be less than [\$75] <u>\$100</u> per day.
- 5 (b) Payments and deductions. -- All payments of pay and
- 6 service shall be made by the Adjutant General in the usual
- 7 manner. No deductions shall be made from the pay of officers or
- 8 enlisted personnel in active State service for dues or other
- 9 financial obligations imposed by any bylaws, rules or
- 10 regulations of a civil character.
- 11 Section 2. This act shall take effect immediately.
