AN ACT

1 Amending the act of April 14, 1972 (P.L.233, No.64), entitled  
2 "An act relating to the manufacture, sale and possession of  
3 controlled substances, other drugs, devices and cosmetics;  
4 conferring powers on the courts and the secretary and  
5 Department of Health, and a newly created Pennsylvania Drug,  
6 Device and Cosmetic Board; establishing schedules of  
7 controlled substances; providing penalties; requiring  
8 registration of persons engaged in the drug trade and for the  
9 revocation or suspension of certain licenses and  
10 registrations; and repealing an act," further providing for  
11 schedules of controlled substances.

12 The General Assembly of the Commonwealth of Pennsylvania  
13 hereby enacts as follows:

14 Section 1. Section 4(1)(ii) of the act of April 14, 1972  
15 (P.L.233, No.64), known as The Controlled Substance, Drug,  
16 Device and Cosmetic Act, amended June 23, 2011 (P.L.36, No.7),  
17 is amended to read:

18 Section 4. Schedules of Controlled Substances.--The  
19 following schedules include the controlled substances listed or  
20 to be listed by whatever official name, common or usual name,  
21 chemical name, or trade name designated.

1 (1) Schedule I--In determining that a substance comes within  
2 this schedule, the secretary shall find: a high potential for  
3 abuse, no currently accepted medical use in the United States,  
4 and a lack of accepted safety for use under medical supervision.  
5 The following controlled substances are included in this  
6 schedule:

8 (ii) Any of the following opium derivatives, their salts,  
9 isomers and salts of isomers, unless specifically excepted,  
10 whenever the existence of such salts, isomers and salts of  
11 isomers is possible within the specific chemical designation:

- 13 2. Acetyldihydrocodeine.
- 14 3. Benzylmorphine.
- 15 4. Codeine methylbromide.
- 16 5. Codeine-N-Oxide.
- 17 6. Cyprenorphine.
- 18 7. Desomorphine.
- 19 8. Dihydromorphine.
- 20 9. Etorphine.
- 21 10. Heroin.
- 22 11. Hydromorphanol.
- 23 12. Methyldesorphine.
- 24 13. Methylhydromorphine.
- 25 14. Morphine methylbromide.
- 26 15. Morphine methylsulfonate.
- 27 16. Morphine-N-Oxide.
- 28 17. Myrophine.
- 29 18. Nicocodeine.
- 30 19. Nicomorphine.

1 20. Normorphine.

2 21. Pholcodine.

3 22. Thebacon.
