8_	Section 3. Processing of payments.	

- 1 (a) General rule. The department may process supplemental
- 2 security income state supplement payments for other states that
- 3 enter into contracts, memorandums of understanding or other-
- 4 agreements with the department.
- 5 (b) Contracts. The department may enter into contracts,
- 6 memorandums of understanding or any other agreements, on a
- 7 contingent fee or other basis, relating to the its authority
- 8 under subsection (a).
- 9 Section 4. State Supplement Payments Processing Account.
- 10 (a) Establishment. There is established in the General Fund
- 11 an account known as the State Supplement Payments Processing
- 12 Account. The monies of the account are hereby appropriated to
- 13 the department on a continuing basis as provided by this act.
- 14 (b) Funding. All moneys collected or received from
- 15 processing supplemental security income state supplement
- 16 payments for other states shall be deposited into the account.
- (c) Limitation of administrative costs. Each fiscal year,
- 18 no more than \$4,500,000 may be expended from the account on the-
- 19 administrative costs related to activities performed under this-
- 20 act.
- 21 (d) Transfer of balance. Any moneys remaining in the
- 22 account after making expenditures under subsection (c) shall be-
- 23 annually transferred to the General Fund.
- 24 Section 5. Reporting.
- 25 The department shall issue a report to the Governor, the
- 26 chairman and minority chairman of the Appropriations Committee
- 27 of the Senate, and the chairman and minority chairman of the-
- 28 Appropriations Committee of the House of Representatives, by
- 29 March 31 of each year, which shall contain at least the
- 30 following information:

1	(1) A detailed breakdown of the department's
2	administrative costs incurred for activities authorized by
3	this act for the 12 months prior to the date of the report.
4	(2) The total moneys deposited into the account by the
5	department for activities authorized by this act during the
6	period covered by the report.
7	(3) A detailed estimate of the department's
8	administrative costs for activities authorized by this act
9	for the next fiscal year that commences after the date of the
10	report, including the projected cost of any contract
11	authorized under section 3 (b).
12	Section 6. Construction.
13	Nothing in this act shall be construed:
14	(1) As a waiver of sovereign immunity for the purposes
15	of 1 Pa.C.S. § 2310 (relating to sovereign immunity
16	reaffirmed; specific waiver).
17	(2) As authorizing the department or the Commonwealth to
18	indemnify any other party for any loss, damage or shortfall
19	associated with any contract, memorandum of understanding or
20	any other agreement to process supplemental security income
21	state supplement payments for other states.
22	Section 7. Effective date.
23	This act shall take effect immediately.
24	SECTION 1. SHORT TITLE.
25	THIS ACT SHALL BE KNOWN AND MAY BE CITED AS THE SUPPLEMENTAL
26	SECURITY INCOME STATE SUPPLEMENT PAYMENTS FOR OUT-OF-STATE
27	PAYORS ACT.
28	SECTION 2. DEFINITIONS.
29	THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ACT SHALL

- 2 "ACCOUNT." THE SSP PROCESSING ACCOUNT ESTABLISHED IN SECTION
- 3 4.
- 4 "DEPARTMENT." THE TREASURY DEPARTMENT OF THE COMMONWEALTH.
- 5 SECTION 3. PROCESSING OF PAYMENTS.
- 6 (A) GENERAL RULE. -- THE DEPARTMENT MAY PROCESS SUPPLEMENTAL
- 7 SECURITY INCOME STATE SUPPLEMENT PAYMENTS FOR OUT-OF-STATE
- 8 PAYORS.
- 9 (B) CONTRACTS. -- THE DEPARTMENT MAY ENTER INTO CONTRACTS, ON
- 10 A CONTINGENT FEE OR OTHER BASIS, ASSOCIATED WITH OR ARISING OUT
- 11 OF THE ACTIVITIES OF THE DEPARTMENT UNDER SUBSECTION (A).
- 12 SECTION 4. ACCOUNT.
- 13 (A) ESTABLISHMENT.--THERE IS ESTABLISHED A RESTRICTED
- 14 ACCOUNT IN THE GENERAL FUND TO BE KNOWN AS THE SSP PROCESSING
- 15 ACCOUNT. THE DEPARTMENT SHALL CREDIT TO THE ACCOUNT ALL FUNDS
- 16 COLLECTED OR RECEIVED FROM PROCESSING SUPPLEMENTAL SECURITY
- 17 INCOME STATE SUPPLEMENT PAYMENTS FOR OUT-OF-STATE PAYORS. ON
- 18 JULY 31 OF EACH YEAR, ALL FUNDS IN THE ACCOUNT WHICH HAVE NOT
- 19 BEEN APPROPRIATED BY THE GENERAL ASSEMBLY IN ACCORDANCE WITH
- 20 SUBSECTION (B) SHALL BE TRANSFERRED TO THE GENERAL FUND.
- 21 (B) USE.--THE GENERAL ASSEMBLY SHALL APPROPRIATE FUNDS FROM
- 22 THE ACCOUNT TO SUPPORT THE DEPARTMENT'S ACTIVITIES UNDER THIS
- 23 ACT. THE DEPARTMENT SHALL SUBMIT A REQUEST FOR THE APPROPRIATION
- 24 OF THE FUNDS UNDER ARTICLE VI OF THE ACT OF APRIL 9, 1929
- 25 (P.L.177, NO.175), KNOWN AS THE ADMINISTRATIVE CODE OF 1929.
- 26 SECTION 5. REPORTING.
- 27 THE DEPARTMENT SHALL, BY MARCH 31 OF EACH YEAR, ISSUE A
- 28 REPORT TO THE GOVERNOR, THE MAJORITY CHAIR AND THE MINORITY
- 29 CHAIR OF THE APPROPRIATIONS COMMITTEE OF THE SENATE AND THE
- 30 MAJORITY CHAIR AND MINORITY CHAIR OF THE APPROPRIATIONS

- 1 COMMITTEE OF THE HOUSE OF REPRESENTATIVES. THE REPORT SHALL
- 2 CONTAIN AT LEAST THE FOLLOWING INFORMATION:
- 3 (1) A DETAILED BREAKDOWN OF THE DEPARTMENT'S OPERATING
- 4 COSTS AND OTHER COSTS INCURRED FOR ACTIVITIES AUTHORIZED
- 5 UNDER THIS ACT FOR THE 12 MONTHS PRIOR TO THE DATE OF THE
- 6 REPORT.
- 7 (2) THE TOTAL REVENUE COLLECTED BY THE DEPARTMENT FOR
- 8 ACTIVITIES AUTHORIZED UNDER THIS ACT DURING THE PERIOD
- 9 COVERED BY THE REPORT.
- 10 (3) A DETAILED ESTIMATE OF THE DEPARTMENT'S OPERATING
- 11 COSTS AND OTHER COSTS FOR ACTIVITIES AUTHORIZED UNDER THIS
- 12 ACT FOR THE NEXT FISCAL YEAR THAT COMMENCES AFTER THE DATE OF
- 13 THE REPORT, INCLUDING THE PROJECTED COST OF A CONTRACT
- 14 AUTHORIZED UNDER SECTION 3(B).
- 15 SECTION 6. LIMITATIONS.
- 16 THE FOLLOWING SHALL APPLY TO AN ACTIVITY AUTHORIZED UNDER
- 17 THIS ACT:
- 18 (1) NOTHING UNDER THIS ACT, INCLUDING, BUT NOT LIMITED
- 19 TO, A CONTRACT AUTHORIZED UNDER THIS ACT AND THE PROCESSING
- OF A SUPPLEMENTAL SECURITY INCOME STATE SUPPLEMENT PAYMENT
- 21 FOR OUT-OF-STATE PAYORS, SHALL BE CONSTRUED TO PERMIT OR
- 22 AUTHORIZE THE WAIVER OF SOVEREIGN IMMUNITY FOR THE PURPOSES
- 23 OF 1 PA.C.S. § 2310 (RELATING TO SOVEREIGN IMMUNITY
- 24 REAFFIRMED; SPECIFIC WAIVER).
- 25 (2) NOTHING UNDER THIS ACT SHALL PERMIT THE DEPARTMENT
- OR THE COMMONWEALTH TO INDEMNIFY ANOTHER PARTY FOR A LOSS,
- 27 DAMAGE OR SHORTFALL ASSOCIATED WITH A CONTRACT TO PROCESS
- 28 SUPPLEMENTAL SECURITY INCOME STATE SUPPLEMENT PAYMENTS FOR
- 29 OUT-OF-STATE PAYORS.
- 30 SECTION 31. APPROPRIATION.

- 1 FOR FISCAL YEAR 2014-2015, \$4,500,000 IS APPROPRIATED ON A
- 2 CONTINUING BASIS FROM THE ACCOUNT TO THE DEPARTMENT TO SUPPORT
- 3 THE DEPARTMENT'S ACTIVITIES UNDER THIS ACT.
- 4 SECTION 32. EFFECTIVE DATE.
- 5 THIS ACT SHALL TAKE EFFECT IMMEDIATELY.
