A RESOLUTION

Recognizing April 2, 2013, as "World Autism Awareness Day" in 1 Pennsylvania. 2 3 WHEREAS, Autism spectrum disorder is a complex disability requiring greater recognition and understanding to ensure that 4 5 all individuals living with an autism spectrum disorder are 6 accurately diagnosed and appropriately supported throughout 7 their lives; and 8 WHEREAS, Autism spectrum disorder is a developmental disability resulting in significant impairment of an 9 individual's ability to learn, develop healthy interactive 10 11 behaviors and understand verbal, nonverbal and reciprocal 12 communication; and 13 WHEREAS, Autism spectrum disorder is the result of a

14 neurological disorder affecting brain function, the complexity

of which few members of the general public understand; and WHEREAS, Although a cure for autism spectrum disorder has not been found, individuals living with an autism spectrum disorder can be assisted in reaching their greatest potential through accurate early diagnosis, appropriate education and

7 WHEREAS, Nationally about 1 in 88 children and 1 in 54 boys 8 are living with an autism spectrum disorder and prevalence 9 figures are growing; and

10 WHEREAS, The number of adults living with an autism spectrum 11 disorder is expected to increase dramatically over the next few 12 years as adolescents age into adulthood, and autism spectrum 13 disorder has become an urgent public health concern that is more 14 common than previously thought; and

15 WHEREAS, The Department of Public Welfare created the Office 16 of Developmental Programs, which includes the Bureau of Autism 17 Services, to provide expertise and support for all agencies 18 serving Pennsylvanians living with an autism spectrum disorder; 19 and

20 WHEREAS, The creation of the Bureau of Autism Services, along 21 with the Commonwealth's commitment to fund additional services 22 and support for children and adults living with an autism 23 spectrum disorder, will bring about a new day for those 24 individuals and their families; and

25 WHEREAS, The sixth annual World Autism Awareness Day is April 26 2, 2013, and every year autism organizations around the world 27 celebrate the day with unique fundraising and awareness-raising 28 events, as well as engage in activities that help to increase 29 and develop world knowledge of the autism epidemic and impart 30 information regarding the importance of early diagnosis and
