A RESOLUTION

- Designating the month of May 2013 as "Celebrate to Live Month" in Pennsylvania.
- 3 WHEREAS, The days of youth represent a vibrant time filled
- 4 with an array of challenges and beams of hope and promise for
- 5 the future; and
- 6 WHEREAS, Unfortunately, these years sometimes are accompanied
- 7 by a great deal of peer pressure to use alcohol and illegal
- 8 drugs as a means of securing false enjoyment; and
- 9 WHEREAS, When these illegal substances are introduced into
- 10 the celebrations and activities of teens, all too often tragedy
- 11 results in promising futures being prematurely snuffed out and
- 12 lives permanently scarred; and
- 13 WHEREAS, Additional penalties and consequences follow, as any
- 14 minor who purchases, consumes, transports or is in possession of
- 15 alcoholic beverages faces a 90-day suspension of driver's

- 1 license and a fine of up to \$300, and a one-year suspension and
- 2 a fine of up to \$500 for a subsequent offense; and
- 3 WHEREAS, A minor with a blood alcohol content of 0.02% or
- 4 greater while driving also faces prosecution for driving under
- 5 the influence; and
- 6 WHEREAS, A minor carrying or using a false identification
- 7 card faces a 90-day to one-year license suspension, a fine of up
- 8 to \$500 and possible imprisonment of up to 90 days or two years
- 9 for a third and subsequent offense; and
- 10 WHEREAS, A minor under 16 years of age would be subject to
- 11 the same criminal sanctions and would not be able to obtain a
- 12 driver's license for 90 days, which would not start until the
- 13 minor acknowledges the notice of violation to the Department of
- 14 Transportation; therefore be it
- 15 RESOLVED, That the House of Representatives designate the
- 16 month of May 2013 as "Celebrate to Live Month" in Pennsylvania
- 17 and urge all teenagers to enjoy the special time of their youth,
- 18 but to celebrate and enjoy it responsibly.
