A RESOLUTION

- Designating the month of February 2014 as "American Heart Month" in Pennsylvania.
- 3 WHEREAS, While progress has been significant in reducing
- 4 deaths from heart disease, it is still the number one killer of
- 5 both women and men; and
- 6 WHEREAS, Cardiovascular disease is the nation's leading cause
- 7 of death and costliest disease with direct and indirect costs
- 8 estimated to be \$312.6 billion; and
- 9 WHEREAS, Between 1999 and 2009, the rate of deaths from
- 10 cardiovascular diseases fell 32.7%, but still accounted for
- 11 nearly one in three deaths in the nation; and
- 12 WHEREAS, About 2,150 people die from cardiovascular diseases
- 13 each day, accounting for about one death every 40 seconds; and

- 1 WHEREAS, Over 12,700 Pennsylvanians died from cardiovascular
- 2 disease in 2011; and
- 3 WHEREAS, The American Heart Association's 2020 impact goal
- 4 seeks to improve the cardiovascular health of all Americans by
- 5 20% while reducing deaths from cardiovascular diseases and
- 6 stroke by 20% through research, population-level and community-
- 7 level interventions and public health and policy measures; and
- 8 WHEREAS, Efforts of the American Heart Association encourage
- 9 citizens to help save lives by calling 911 if symptoms occur,
- 10 become trained in CPR and encourage comprehensive automated
- 11 external defibrillator programs in their communities; and
- 12 WHEREAS, The American Heart Association is celebrating
- 13 February 2014 as American Heart Month and promoting education
- 14 and awareness by encouraging citizens to learn the warning signs
- 15 of heart attack and stroke; therefore be it
- 16 RESOLVED, That in recognition of the importance of the
- 17 ongoing fight against heart disease, the House of
- 18 Representatives designate the month of February 2014 as
- 19 "American Heart Month" in Pennsylvania and urge all
- 20 Pennsylvanians to recognize the critical importance of tools and
- 21 skills that will increase survival rates from cardiac arrest and
- 22 save thousands of lives each year.
