## A RESOLUTION

- 1 Commemorating the 100th anniversary of the organizing of the 2 Veterans of Foreign Wars in Pittsburgh, Pennsylvania.
- 3 WHEREAS, September 14 through 17, 2014, marks the 100th
- 4 anniversary of the consolidation of three organizations created
- 5 by Spanish-American War veterans into the Veterans of Foreign
- 6 Wars (VFW) in Pittsburgh, Pennsylvania; and
- 7 WHEREAS, For four days in 1904, veterans traveled from all
- 8 areas of the United States to Pittsburgh, Pennsylvania, to unify
- 9 United States veterans under one organizational umbrella of a
- 10 nationalized Veterans of Foreign Wars by drafting a constitution
- 11 and bylaws, and
- 12 WHEREAS, During the VFW convention, then Commander-in-Chief,

- 1 Rice W. Means, of Denver, Colorado, entreated his comrades to
- 2 instill in all Americans "a patriot spirit and devotion to the
- 3 flag"; and
- 4 WHEREAS, Mr. Means challenged those in attendance, "We who
- 5 have seen service in foreign wars, know of the horrors of
- 6 unpreparedness for war. It would be a crime to send our young
- 7 men unprepared into another warfare as we were. We want peace,
- 8 but if war is thrust upon us, we want to be prepared for it.";
- 9 and
- 10 WHEREAS, The VFW offers many programs to veterans who have
- 11 served overseas during an operation or conflict with hostile
- 12 fire or imminent danger, such as the National Military Services,
- 13 Operation Uplink, Military Assistance Program, Unmet Needs and
- 14 National Veterans Services; and
- 15 WHEREAS, Over the years the VFW has been directly involved in
- 16 communities through VFW Posts, Men's and Ladies' Auxiliaries,
- 17 VFW community service programs, citizen education programs,
- 18 youth scholarship programs, safety programs and the VFW National
- 19 Home for Children; and
- 20 WHEREAS, The VFW fought for military pensions after World War
- 21 I, planned the establishment of the Veterans Administration in
- 22 1930, lobbied for the GI Bill of Rights after World War II,
- 23 helped develop the national cemetery system for veterans and
- 24 contributed millions of dollars to cancer research since the
- 25 1950s; and
- 26 WHEREAS, The VFW has challenged elected officials when
- 27 veterans of our country are not being taken care of, such as the
- 28 underfunding of health care within the Veterans Administration;
- 29 therefore be it
- 30 RESOLVED, That the House of Representatives celebrate the

- 1 100th anniversary of the organizing of the Veterans of Foreign
- 2 Wars in Pittsburgh, Pennsylvania.
