AN ACT

Amending the act of December 7, 1982 (P.L.784, No.225), 1 entitled, as amended, "An act relating to dogs, regulating the keeping of dogs; providing for the licensing of dogs and 3 kennels; providing for the protection of dogs and the 4 detention and destruction of dogs in certain cases; 5 regulating the sale and transportation of dogs; declaring 6 dogs to be personal property and the subject of theft; 7 providing for the abandonment of animals; providing for the 8 assessment of damages done to animals; providing for payment 9 of damages by the Commonwealth in certain cases and the 10 liability of the owner or keeper of dogs for such damages; 11 imposing powers and duties on certain State and local 12 officers and employees; providing penalties; and creating a 13 Dog Law Restricted Account," further providing for 14 definitions and for revocation or refusal of kennel licenses. 15 16 The General Assembly of the Commonwealth of Pennsylvania 17 hereby enacts as follows: 18 Section 1. Section 102 of the act of December 7, 1982 19 (P.L.784, No.225), known as the Dog Law, is amended by adding a 20 definition to read: 21 Section 102. Definitions. 22 The following words and phrases when used in this act shall

have, unless the context clearly indicates otherwise, the

- 3 "Immediate family." Includes a spouse, child, parent,
- 4 brother, sister, grandparent and grandchild and a spouse
- 5 thereof, a domestic partner and any other individual related by
- 6 blood or affinity whose close association with the licensee is
- 7 the equivalent of a family relationship.

- 9 Section 2. Section 211(a) introductory paragraph, amended
- 10 October 9, 2008 (P.L.1450, No.119), is amended to read:
- 11 Section 211. Revocation or refusal of kennel licenses.
- 12 (a) General powers of secretary. -- The secretary shall revoke
- 13 a kennel license, dealer license or out-of-state dealer license
- 14 if a licensee is convicted of a violation of 18 Pa.C.S. § 5511
- 15 (relating to cruelty to animals) or of substantially similar
- 16 conduct pursuant to a cruelty law of another state. The
- 17 secretary shall not issue a kennel license, dealer license or
- 18 out-of-state dealer license to a person that has been convicted
- 19 of a violation of 18 Pa.C.S. § 5511 within the last ten years
- 20 nor to a person who is a member of the immediate family of the

- 21 convicted licensee nor to any person who resides at the same
- 22 address who seeks to operate a kennel at the same location as
- 23 the convicted licensee. The secretary may revoke or refuse to
- 24 issue a kennel license, dealer license or out-of-state dealer
- 25 license for any one or more of the following reasons:
