1 (b) Composition.--The board shall be composed of ten members
2 as follows:

(1) The Attorney General.

4 (2) Two judges of the courts of common pleas from5 different counties.

6 (3) Two sheriffs [or chief deputies] from different
7 counties with a minimum of six years experience as a sheriff
8 or chief deputy.

9 (4) Three individuals from different counties with a 10 minimum of eight years experience each as a deputy sheriff. 11 One of the three shall be currently employed in the capacity 12 of deputy sheriff with the rank of sergeant or deputy 13 sheriff.

14 (5) One educator qualified in the field of curriculum15 design.

16 (6) One county commissioner.

(d) Vacancies.--A member appointed to fill a vacancy created by any reason other than expiration of a term shall be appointed for the unexpired term of the member [whom he is to succeed] who the appointee succeeds in the same manner as the original

(g) [Chairman] <u>Chair</u>.--The members of the board shall elect
a [chairman] <u>chair</u> from among the members to serve for a period
of one year. A [chairman] <u>chair</u> may be elected to serve
successive terms. The Governor shall designate the first
[chairman] <u>chair</u> for organizational purposes only.

(h) Meetings and quorum.--The [chairman] <u>chair</u> shall summon
30 the members of the board to the first meeting within 120 days of

1 the effective date of this act. The board shall meet at least 2 four times each year. Special meetings may be called by the 3 [chairman] <u>chair</u> of the board or upon written request of three 4 members. A quorum shall consist of five members.

5 Section 4. Section 4 of the act is amended to read:6 Section 4. Powers and duties of the board.

7 The board, with the review and approval of the commission, 8 shall:

9 (1) Establish, implement and administer the [Deputy 10 Sheriffs'] <u>Sheriff and Deputy Sheriff</u> Education and Training 11 Program according to the minimum requirements set forth in 12 this act.

13 (2) Establish, implement and administer requirements for
14 the minimum courses of study and training for <u>sheriffs and</u>
15 deputy sheriffs.

(3) Establish, implement and administer requirements for
 courses of study and in-service training for <u>sheriffs holding</u>
 <u>office and</u> deputy sheriffs appointed prior to the effective
 date of this act.

(4) Establish, implement and administer requirements for
a continuing education program for all <u>sheriffs and</u> deputy
sheriffs concerning subjects the board may deem necessary and
appropriate for the continued education and training of
<u>sheriffs and</u> deputy sheriffs.

(5) Approve or revoke the approval of any school which
may be utilized to comply with the educational and training
requirements of this act.

28 (6) Establish the minimum qualifications for instructors29 and certify instructors.

4 (8) Promote the most efficient and economical program
5 for <u>sheriffs and</u> deputy sheriff training by utilizing
6 existing facilities, programs and qualified State and local
7 personnel.

8 (9) Certify <u>sheriffs and</u> deputy sheriffs who have 9 satisfactorily completed the basic education and training 10 requirements of this act and issue appropriate certificates 11 to them.

12 (9.1) Revoke the certification of sheriffs and deputy
13 sheriffs in accordance with section 7.1.

14 (9.2) Reinstate previously revoked certifications of 15 sheriffs and deputy sheriffs where the board finds that the 16 circumstances which led to the revocation of certification 17 are no longer an impediment to certification.

18 (10) Make rules and regulations and perform other duties
19 as may be reasonably necessary or appropriate to administer
20 [the education and training program for deputy sheriffs] this
21 act.

(11) Make an annual report to the Governor and to theGeneral Assembly concerning:

(i) The administration of the [Deputy Sheriffs']
 Sheriff and Deputy Sheriff Education and Training
 Program.

The [Deputy Sheriffs'] <u>Sheriff and Deputy Sheriff</u> Education and Training Program shall include appropriate training for not less than 160 hours which content and hours of instruction shall be determined by the board, subject to the review and approval of the commission.

7 Section 6. Continuing education.

8 The board, with the review and approval of the commission, shall establish a continuing education program for all sheriffs 9 10 and deputy sheriffs, which shall include not less than 20 hours 11 of continuing education every two years, concerning subjects the 12 board may deem necessary and appropriate for the continued 13 education and training of sheriffs and deputy sheriffs. 14 Section 6. 11	(g) Purpose and legislative intentIt is hereby declared
12	to be a public policy of this Commonwealth that sheriffs receive
13	and maintain education and training equivalent to that required
14	by law of deputy sheriffs in order to preserve the safety of
15	county facilities, employees and residents. It is further
16	declared that a newly elected sheriff have an opportunity to
17	satisfy the requirements of this act during the sheriff's first
18	term, notwithstanding past training and experience.

this act shall, at the end of two years from the effective date 1 2 of this act, be ineligible to receive any salary, compensation 3 or other consideration or thing of value for the performance of [his] duties as a deputy sheriff unless [he] the deputy sheriff 4 has met all of the requirements established pursuant to this act 5 and has been duly certified as having met those requirements by 6 7 the board, with the review and approval of the commission, 8 unless the deputy sheriff is granted additional time to complete [his] training by the board, with the review and approval of the 9 10 commission. Any new deputy hired by the sheriff after July 1, 1985 shall have one year in which to complete [his or her] 11 12 training.

(d) Continuing education.--Any full-time or part-time deputy sheriff who fails to meet and fails to be certified as having met the requirements for continuing education established by the board, with the review and approval of the commission, shall be ineligible to receive any salary, compensation or other consideration or thing of value for the performance of [his] duties as a deputy sheriff.

23 (a) Revocation of deputy sheriff certification.--The board 24 shall revoke the certification of any deputy sheriff for one or 25 more of the following:

- 26 (1) Conviction for a felony or misdemeanor of the first
   27 or second degree.
- 28 (2) Where the board determines the person was dismissed
  29 for cause from employment as a deputy sheriff.

2	(4) Where the board determines the person has committed
3	misconduct which makes the person unfit to perform the duties

8	(ii) Cheating on board examinations or skill tests.
9	(b) Revocation of sheriff certificationThe board shall
10	revoke the certification of a sheriff only after the sheriff is
11	removed from office. Nothing in this act shall be interpreted as
12	providing grounds for removal of a sheriff from office, except
13	as provided for by Article VI of the Constitution of
14	<u>Pennsylvania.</u>
15	(c) Notification by sheriffIn the case of a deputy
16	sheriff, it shall be the responsibility of the sheriff to notify
17	the board within 15 days of the occurrence of an event described
18	under subsection (a).
19	(d) Notification by county commissionersIn the case of a
20	sheriff, it shall be the responsibility of the county
21	commissioners to notify the board within 15 days of a sheriff's
22	removal from office.
23	(e) RegulationsThe board shall establish, with the
24	approval of the commission, regulations providing for the
25	following:
26	(1) Notice of a revocation and the right of sheriffs and
27	deputy sheriffs to request a hearing.
28	(2) Standards and guidelines for application for

4 Establishment.--There is hereby established a special (a) restricted receipts account within the General Fund of the State 5 Treasury, which shall be known as the [Deputy Sheriffs'] Sheriff 6 7 and Deputy Sheriff Education and Training Account, for the 8 purpose of financing training program expenses, the costs of administering the program, reimbursements to counties and all 9 10 other costs associated with the activities of the board and the 11 implementation of this act.

13 (c) Disposition of moneys collected.--The moneys collected 14 under subsection (b) shall be forwarded semiannually by the 15 sheriff of an individual county to the State Treasurer for 16 deposit into the account[. All moneys received by the treasurer in excess of the amount necessary] and used exclusively to cover 17 18 the costs and expenses of the [training program shall be 19 transferred from the special restricted receipts account to the 20 General Fund of the Commonwealth on an annual basis with such reserve maintained as will be adequate to assure the continued 21 22 operation of the Deputy Sheriffs'] <u>Sheriff and Deputy Sheriff</u> 23 Education and Training Program.

(e) Audit.--The Auditor General shall conduct an audit of the account as [he] <u>the Auditor General</u> may deem necessary or advisable from time to time but no less often than once every three years.

1 Section 9. Reimbursement to counties.

2 Each county shall pay the ordinary and necessary living and 3 travel expenses and the regular salary of their sheriff and deputy sheriffs while attending approved schools. The commission 4 shall provide for reimbursement to each county of 100% of the 5 regular salaries of their <u>sheriff and</u> deputy sheriffs and 100% 6 7 of the ordinary and necessary living and travel expenses 8 incurred by their <u>sheriff and</u> deputy sheriffs while attending certified [deputy sheriffs'] <u>sheriff and deputy sheriff</u> basic 9 training or continuing education schools if the county adheres 10 to the training standards set forth in this act and established 11 12 by the board with the review and approval of the commission. The 13 commission shall provide for 100% of the tuition incurred by 14 sheriff and deputy sheriffs while attending certified [deputy sheriffs'] sheriff and and deputy sheriff basic training or 15 continuing education schools. 16

17 Section 11. This act shall take effect in 60 days.
