- 1 Amending the act of July 28, 1953 (P.L.723, No.230), entitled,
- as amended, "An act relating to counties of the second class
- and second class A; amending, revising, consolidating and
- 4 changing the laws relating thereto," further providing for
- 5 requests for examinations and reports of coroners.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 1235.1 of the act of July 28, 1953
- 9 (P.L.723, No.230), known as the Second Class County Code, added
- 10 December 17, 1990 (P.L.728, No.182), is amended to read:
- 11 Section 1235.1. Requests for Examinations and Reports.--(a)
- 12 Requests for examinations or other professional services by
- 13 other counties or persons may be complied with at the discretion
- 14 of the coroner pursuant to guidelines established by the county
- 15 commissioners.
- 16 (b) A set of fees and charges for such examinations or
- 17 professional services shall be established by the coroner,
- 18 subject to approval by the county commissioners, and shall be
- 19 accounted for and paid to the county treasurer pursuant to

- 1 section 1960. Payment for examinations or professional services
- 2 shall be the responsibility of the county or person requesting
- 3 such services.
- 4 (c) The coroner may charge and collect a fee of up to one
- 5 hundred dollars (\$100) for each autopsy report, up to fifty
- 6 dollars (\$50) for each toxicology report, up to fifty dollars
- 7 (\$50) for each inquisition or coroner's report and such other
- 8 fees as may be established from time to time for other reports
- 9 and documents requested by nongovernmental agencies. The fees
- 10 collected shall be accounted for and paid to the county
- 11 treasurer pursuant to section 1960 and shall be used to defray

- 12 the expenses of staff, equipment and supplies related to
- 13 <u>determining cause and manner of death, and those expenses</u>
- 14 involved in the county complying with the provisions of the act
- 15 of March 2, 1988 (P.L.108, No.22), referred to as the Coroners'
- 16 Education Board Law. <u>IN COUNTIES OF THE SECOND CLASS, THE</u>
- 17 COLLECTED FEES SHALL ALSO BE USED TO SUPPLEMENT ANY OTHER MONEYS
- 18 TO DEFRAY THE EXPENSES OF STAFF, EQUIPMENT AND SUPPLIES RELATED
- 19 TO DETERMINING CAUSE AND MANNER OF DEATH.
- 20 Section 2. This act shall take effect in 60 days.
