A RESOLUTION

- 1 Designating the month of April 2014 as "Child Abuse Prevention Month" in Pennsylvania.
- 3 WHEREAS, Each year, more than one million children in the
- 4 United States are documented as the victims of child abuse; and
- 5 WHEREAS, In 2012, there were 3,565 substantiated cases of
- 6 child abuse in this Commonwealth, with 33 children dying as a
- 7 result of abuse and neglect; and
- 8 WHEREAS, More than half of the perpetrators in 2012 had a
- 9 parental relationship with the child; and
- 10 WHEREAS, In 2010 through 2011, the Pennsylvania Coalition
- 11 Against Rape provided services to more than 7,786 child victims
- 12 of sexual violence; and
- 13 WHEREAS, In 2012, 79% of substantiated reports were made by
- 14 mandated reporters; and
- 15 WHEREAS, Child abuse crosses all racial, economic and
- 16 geographic boundaries; and

- 1 WHEREAS, Pennsylvania Family Support Alliance trained more
- 2 than 30,100 professionals and community members in 2010 through
- 3 2012; and
- 4 WHEREAS, The damaging effects of child abuse include, but are
- 5 not limited to, school failure, alcohol and drug abuse and
- 6 physical and psychological difficulties; and
- 7 WHEREAS, Child abuse can and must be prevented and awareness
- 8 raised so that families learn they have access to community
- 9 resources which offer support, information and guidance to help
- 10 stop or prevent abusive behaviors or conditions; and
- 11 WHEREAS, Many Pennsylvanians in schools, social service
- 12 agencies, churches and neighborhood groups throughout this
- 13 Commonwealth, including the Pennsylvania Family Support Alliance
- 14 and the Pennsylvania Coalition Against Rape, are working to
- 15 support the victims of child abuse and prevent future abuse; and
- 16 WHEREAS, The General Assembly enacted the Newborn Protection
- 17 Act, or Safe Haven Law, in 2002; and
- 18 WHEREAS, In 2003, an amendment to the Constitution of
- 19 Pennsylvania was approved permitting child victims to testify
- 20 electronically; and
- 21 WHEREAS, In 2006, the General Assembly enacted a
- 22 comprehensive child abuse reform package (Act 179), updating the
- 23 Child Protective Services Law and lengthening the statute of
- 24 limitations for sexual offenses against children; and
- 25 WHEREAS, In 2011, the General Assembly enacted legislation
- 26 (Act 111) to ensure that the Commonwealth meets federally
- 27 mandated standards under the Adam Walsh Child Protection and
- 28 Safety Act of 2006 (Public Law 109-248, 120 Stat. 587) by
- 29 strengthening sex offender registration and notification; and
- 30 WHEREAS, Also in 2011, the General Assembly created the Task

- 1 Force on Child Protection to examine the practices, processes
- 2 and procedures relating to the response to child abuse and
- 3 reporting of child abuse and to make recommendations to the
- 4 Governor and General Assembly; and
- 5 WHEREAS, In spite of these efforts, more needs to be done to
- 6 guarantee a childhood free of abuse and victimization to every
- 7 child in this Commonwealth; therefore be it
- 8 RESOLVED, That the Senate designate the month of April 2014
- 9 as "Child Abuse Prevention Month" in Pennsylvania; and be it
- 10 further
- 11 RESOLVED, That the Senate commend those persons and community
- 12 groups that work to treat and prevent child abuse and urge all
- 13 Pennsylvanians to do their part in preventing the tragedy of
- 14 child abuse.
