## A RESOLUTION

- Designating the month of April 2014 as "The Month of the Young Child" in Pennsylvania.
- 3 WHEREAS, There are approximately 724,000 children from birth
- 4 to five years of age in Pennsylvania today; and
- 5 WHEREAS, A young child's brain forms 700 neural synapses a
- 6 second, and the circuits for key functions such as vision,
- 7 hearing, language and higher cognitive function develop the most
- 8 in the first five years of life; and
- 9 WHEREAS, The creation of these circuits is affected by a
- 10 child's early learning environment; and
- 11 WHEREAS, Young children learn best when they have proper
- 12 health and nutrition, a safe and stable family and home life and
- 13 activities that stimulate creativity, curiosity and all the
- 14 skills they will need to succeed in school and in life; and
- 15 WHEREAS, High-quality early learning and child development
- 16 play a major role in a child's future success in school and in
- 17 life; and

- 1 WHEREAS, Talking, reading and playing with children from
- 2 birth builds the language, math and social skills they need to
- 3 be ready for kindergarten; and
- 4 WHEREAS, Forty years of research show that children receiving
- 5 high-quality early education are more likely to be prepared for
- 6 and do better in school, graduate high school, attend college or
- 7 participate in job training; and
- 8 WHEREAS, Children attending high-quality early learning
- 9 programs are better prepared for whichever career path they
- 10 choose in the competitive work force, including opportunities in
- 11 law enforcement and the military; and
- 12 WHEREAS, High-quality early learning is especially beneficial
- 13 to children whose educational opportunities are hindered by
- 14 poverty or other circumstances; and
- 15 WHEREAS, Parents and guardians are able to be productive,
- 16 engaged and focused employees when they have stable, affordable
- 17 and high-quality early learning settings for their children; and
- 18 WHEREAS, Research demonstrates high-quality early learning
- 19 saves taxpayer money by reducing the need for special education
- 20 and remedial instruction and decreases drop-out rates, crime and
- 21 incarceration; and
- 22 WHEREAS, High-quality early learning programs in Pennsylvania
- 23 such as Pre-K Counts, Head Start Supplemental Assistance
- 24 Program, Keystone STARS, Early Intervention and evidence-based
- 25 home visiting are sound investments that are preparing our
- 26 youngest children for success in school and in life; and
- 27 WHEREAS, Supporting and retaining a well-trained, early
- 28 learning staff is critical because a highly qualified work force
- 29 is an essential element of a high-quality program; and
- 30 WHEREAS, Unfortunately, there is still far too much unmet

- 1 need for high-quality learning programs in Pennsylvania; and
- 2 WHEREAS, Only 1 in 6 children are able to access high-
- 3 quality, publicly funded pre-k, and only 4.8% of child care
- 4 openings for children birth to four years of age are in the
- 5 highest quality STAR 4 or accredited programs; and
- 6 WHEREAS, Children only have one early childhood experience,
- 7 and delayed investments are lost opportunities; therefore be it
- 8 RESOLVED, That the Senate designate the month of April 2014
- 9 as "The Month of the Young Child" in Pennsylvania and recognize
- 10 that every child in Pennsylvania deserves access to high-quality
- 11 early learning opportunities.
