- 1 Amending Title 68 (Real and Personal Property) of the
- Pennsylvania Consolidated Statutes, in general provisions,
- further providing for definitions; and, in seller
- disclosures, further providing for disclosure form.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 7102 of Title 68 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a definition to read:
- 9 § 7102. Definitions.
- 10 Subject to additional definitions contained in subsequent
- 11 provisions of this part which are applicable to specific
- 12 provisions of this part, the following words and phrases when
- 13 used in this part shall have the meanings given to them in this
- 14 section unless the context clearly indicates otherwise:
- 15 * * *
- 16 <u>"Storm water facility." A basin, pond, ditch, drain, swale,</u>
- 17 culvert, pipe or other manmade feature of land which was
- 18 constructed in accordance with Federal, State or local law or
- 19 regulation to temporarily or permanently convey or manage storm

- 1 water.
- 2 Section 2. Section 7304(b)(13) of Title 68 is amended and
- 3 the subsection is amended by adding a paragraph to read:
- 4 § 7304. Disclosure form.
- 5 * * *
- 6 (b) Contents of property disclosure statement. -- The form of
- 7 property disclosure statement promulgated by the State Real
- 8 Estate Commission shall call for disclosures with respect to all
- 9 of the following subjects:
- 10 * * *
- 11 (13) Soils, drainage [and], boundaries and sinkholes.
- 12 * * *
- 13 (17) Condition, if known, and the location of all storm
- 14 <u>water facilities, including a statement disclosing whether</u>
- ongoing maintenance of the storm water facilities is the
- responsibility of the property owner or the responsibility of
- another person or entity.

- 19 Section 3. For the purpose of implementing the amendment or
- 20 addition of 68 Pa.C.S. § 7304(b)(13) and (17), revisions to the
- 21 property disclosure statement shall be promulgated by the State
- 22 Real Estate Commission within 120 days of the effective date of
- 23 this section as a final-omitted regulation under the act of June
- 24 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act,
- 25 with notice of proposed rulemaking omitted under section 204 of
- 26 the act of July 31, 1968 (P.L.769, No.240), referred to as the
- 27 Commonwealth Documents Law.
- 28 Section 4. This act shall take effect immediately.
