AN ACT

- Amending the act of April 6, 1951 (P.L.69, No.20), entitled "An
- act relating to the rights, obligations and liabilities of
- landlord and tenant and of parties dealing with them and 3
- amending, revising, changing and consolidating the law relating thereto," in recovery of possession, providing for
- early termination of leases by individuals with disabilities
- 7 and senior citizens.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. The act of April 6, 1951 (P.L.69, No.20), known
- 11 as The Landlord and Tenant Act of 1951, is amended by adding a
- 12 section to read:
- Section 514. Early Termination of Leases by Individuals with 13
- Disabilities and Senior Citizens. -- (a) Notwithstanding any 14
- 15 other provision of this act or law, a tenant of a residential
- 16 unit may terminate the lease prior to the date provided in the
- lease by providing the landlord of the residential unit with the 17
- information specified in subsection (b) if the tenant: 18

- 1 (1) has a disability or is a senior citizen; and
- 2 <u>(2) is either:</u>
- 3 (i) awaiting admission and subsequently moves to a health
- 4 care facility; or
- 5 (ii) needs to move and subsequently moves to a family
- 6 member's residence for the express purpose of receiving care
- 7 from a home health care agency for a period of no less than six
- 8 months.
- 9 (b) The following information must be submitted to a
- 10 landlord:
- 11 (1) written notice delivered to the landlord sixty days
- 12 prior to the proposed early termination date informing the
- 13 <u>landlord of the tenant's required admission and move to a health</u>
- 14 care facility or need to move to a family member's residence for
- 15 the express purpose of receiving care from a home health care
- 16 agency for a period of no less than six months;
- 17 (2) certified documentation signed by a licensed physician
- 18 indicating that the tenant, due to medical reasons, is unable to
- 19 continue to live independently in the residential unit and
- 20 requires admission to a health care facility or needs to receive
- 21 care from a home health care agency for a period of no less than
- 22 six months; and
- 23 (3) if applicable, a notarized statement from the tenant's
- 24 family member attesting to the fact that the tenant is a
- 25 relative and will be moving into the family member's residence
- 26 to receive care from a home health care agency for a period of
- 27 no less than six months.
- 28 (c) Nothing under this section shall be construed to relieve
- 29 a tenant to which this section applies of liability for rent or
- 30 any other debt incurred under a lease prior to the termination

- 1 <u>date provided in the lease.</u>
- 2 (d) For the purposes of this section, the following words
- 3 shall have the meanings ascribed to them in this subsection
- 4 unless the context otherwise indicates:
- 5 "Disability." A physical or mental impairment that
- 6 <u>substantially limits one or more major life activities.</u>
- 7 "Health care facility." Any general, chronic disease or
- 8 other type of hospital, personal care home, home health care
- 9 <u>agency</u>, hospice or long-term care nursing facility.
- "Senior citizen." Any person who has attained the age of 62
- 11 years of age or older, or will attain such age during the term
- 12 of an agreement in which the person is a tenant of a residential
- 13 <u>unit.</u>
- 14 Section 2. The provisions of this act shall only apply to
- 15 leases entered into or extended on or after the effective date
- 16 of this section.
- 17 Section 3. This act shall take effect immediately.
