AN ACT

Amending the act of June 28, 1935 (P.L.477, No.193), entitled, as amended, "An act providing for the payment of the salary, medical and hospital expenses of members of the State Police 3 Force, of the enforcement officers and investigators employed by the Pennsylvania Liquor Control Board, and the parole 5 agents, enforcement officers and investigators of the Pennsylvania Board of Probation and Parole, Capitol Police officers, correction employes employed by the Department of 8 Corrections whose principal duty is the care, custody and 9 control of inmates, psychiatric security aides employed by 10 the Department of Public Welfare and the Department of 11 Corrections whose principal duty is the care, custody, and 12 control of the criminally insane, drug enforcement agents of 13 the Office of Attorney General whose principal duty is the 14 enforcement of the drug laws of the Commonwealth, special 15 agents of the Office of Attorney General whose principal duty 16 17 is the enforcement of the criminal laws of the Commonwealth, members of the Delaware River Port Authority Police and of 18 policemen, firemen and park guards by the Commonwealth of 19 Pennsylvania, the Delaware River Port Authority, counties, 20 21 cities, boroughs, towns and townships, and sheriffs and deputy sheriffs who are injured or contract certain diseases 22 in the performance of their duty; and providing that absence 23 during such injury shall not reduce any usual sick leave 24 period," providing for the care of police animals injured in 25 the line of duty. 26

- 27 The General Assembly of the Commonwealth of Pennsylvania
- 28 hereby enacts as follows:

- 1 Section 1. The act of June 28, 1935 (P.L.477, No.193),
- 2 referred to as the Enforcement Officer Disability Benefits Law,
- 3 is amended by adding a section to read:
- 4 <u>Section 2.1. (a) A police animal shall be provided</u>
- 5 <u>veterinary and medical care for any injury suffered in the</u>
- 6 performance of its duties. Veterinary and medical care includes,
- 7 but is not limited to, ambulatory care, including an air
- 8 <u>ambulance</u>, on-going care and medical devices. In no event shall_
- 9 the use of an air ambulance for a police animal take precedence
- 10 over a human similarly situated at the time the air ambulance is
- 11 <u>needed</u>, <u>unless the air ambulance is already engaged in transport</u>
- 12 of the police animal.
- 13 (b) The term "police animal" shall have the same meaning as
- 14 provided in 18 Pa.C.S. § 5511.2 (relating to police animals).
- 15 Section 2. This act shall take effect in 30 days.
