AN ACT

- 1 Designating an overpass on State Route 49 over State Route 15,
- Lawrence Township, Tioga County, as the Lance Corporal
- 3 Michael G. Plank Memorial Bridge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Lance Corporal Michael G. Plank Memorial Bridge.
- 7 (a) Findings.--
- 8 (1) Lance Corporal Michael G. Plank was a 2004 graduate
- 9 of Elkland High School, Tioga County.
- 10 (2) Lance Corporal Plank served in the Marine Corps
- 11 assigned to the 7th Engineer Battalion, 1st Marine Logistics
- 12 Group, Camp Pendleton, California.
- 13 (3) On June 9, 2010, Lance Corporal Plank died while
- 14 supporting combat operations in Helmand Province,
- 15 Afghanistan.

- 1 (4) Lance Corporal Plank received the National Defense
- 2 Medal, the Afghanistan Campaign Medal, the War on Terrorism
- 3 Service Medal, the Non-Article 5 ISAF Medal and the Rifle
- 4 Expert, 2nd Award.
- 5 (b) Designation. -- The overpass on State Route 49 over State
- 6 Route 15, Lawrence Township, Tioga County, is hereby designated
- 7 the Lance Corporal Michael G. Plank Memorial Bridge.
- 8 (c) Signs.--The Department of Transportation shall erect and
- 9 maintain appropriate signs displaying the name of the bridge to
- 10 traffic in both directions on the bridge.
- 11 Section 2. Effective date.
- 12 This act shall take effect in 60 days.
