Amending Title 26 (Eminent Domain) of the Pennsylvania Consolidated Statutes, in special damages for displacement, 2 further providing for moving and related expenses of 3 displaced persons, for replacement housing for homeowners and for replacement housing for tenants and others. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: Section 1. Sections 902(b)(4), 903(a)(1) and 904(a)(1) of 8 Title 26 of the Pennsylvania Consolidated Statutes are amended 10 to read: § 902. Moving and related expenses of displaced persons. 11 12 13 Damages for dislocation of business or farm operation .--(b) 14 A displaced person who is displaced from a place of business or 15 from a farm operation shall be entitled, in addition to any 16 payment received under subsection (a), to damages for 17 dislocation of business or farm operation as follows: 18

(4) Actual reasonable expenses necessary to reestablish

- 1 a displaced farm, nonprofit organization or small business at
- 2 its new site, but not to exceed [\$12,000] <u>\$25,000</u>. Sites
- 3 occupied solely by outdoor advertising signs, displays or
- 4 devices do not qualify for this benefit.

- 6 § 903. Replacement housing for homeowners.
- 7 (a) Additional payments to certain homeowners.--
- 8 (1) In addition to payments otherwise authorized, the
- 9 acquiring agency shall make an additional payment not in
- 10 excess of [\$27,000] \$31,000 to any displaced person who is
- 11 displaced from a dwelling actually owned and occupied by the
- displaced person for not less than 180 days prior to the
- initiation of negotiations for the acquisition of the
- property or the receipt of written notice from the acquiring
- agency of intent to acquire or order to vacate.

- 17 § 904. Replacement housing for tenants and others.
- 18 (a) Payment to certain displaced persons.--
- 19 (1) In addition to amounts otherwise authorized, an
- 20 acquiring agency shall make a payment to or for any displaced
- 21 person displaced from a dwelling not eligible to receive a
- 22 payment under section 903 (relating to replacement housing
- for homeowners), which dwelling was actually and lawfully
- occupied by the displaced person for not less than 90 days
- 25 prior to the initiation of negotiations for acquisition of
- 26 the dwelling or the receipt of written notice from the
- 27 acquiring agency of intent to acquire or order to vacate. The
- 28 payment shall be the amount determined to be necessary to
- 29 enable the displaced person to lease a comparable replacement
- dwelling for a period not to exceed 42 months. The amount

- shall be the additional amount, if any, over the actual
- 2 rental or fair rental value of the acquired dwelling, but not
- 3 more than [\$6,300] \$7,200.

- 5 Section 2. This act shall take effect in 60 days.
