## AN ACT

- 1 Establishing the Veteran's Entrepreneurial Training and Support
- 2 Program; imposing powers and duties on the Department of
- 3 Community and Economic Development; and making an
- 4 appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Veterans
- 9 Entrepreneurial Training and Support Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Department." The Department of Community and Economic
- 15 Development of the Commonwealth.
- 16 "Secretary." The Secretary of Community and Economic
- 17 Development of the Commonwealth.

- 1 "Service-disabled veteran." A veteran who possesses either a
- 2 disability rating letter issued by the United States Department
- 3 of Veterans Affairs or a disability determination from the
- 4 United States Department of Defense.
- 5 "Service-disabled veteran-owned small business." A small
- 6 business owned and controlled by a service-disabled veteran or
- 7 service-disabled veterans or a surviving spouse or permanent
- 8 caregiver of a service-disabled veteran.
- 9 "Small business." A company that is engaged in a for-profit
- 10 enterprise and employs no more than 100 individuals.
- "Veteran." A person who served on active duty in the United
- 12 States Armed Forces, including any of the following:
- 13 (1) A reservist or member of the National Guard who was
- 14 discharged or released from the service under honorable
- 15 conditions.
- 16 (2) A reservist or member of the National Guard who
- 17 completed an initial term of enlistment or qualifying period
- 18 of service.
- 19 (3) A reservist or member of the National Guard who was
- 20 disabled in the line of duty during training.
- "Veteran-owned small business." A small business owned and
- 22 controlled by a veteran or veterans. The term includes a
- 23 service-disabled veteran-owned small business.
- 24 Section 3. Veterans Entrepreneurial Training and Support
- 25 Program.
- The department, in consultation with the Department of
- 27 Military and Veterans Affairs, shall establish the Veterans
- 28 Entrepreneurial Training and Support Program within the
- 29 department to provide small business and entrepreneurial focused
- 30 services to veterans and reservists and the spouses and children

- 1 of veterans and reservists for purposes of assisting those
- 2 individuals in obtaining the skills necessary to create, manage
- 3 and operate a small business.
- 4 Section 4. Veterans business centers.
- 5 (a) Establishment.--In developing the Veterans
- 6 Entrepreneurial Training and Support Program under section 3,
- 7 the department shall create four veterans business centers
- 8 throughout this Commonwealth. The location of the veterans
- 9 business centers shall be at the discretion of the secretary,
- 10 provided that veterans from all areas of this Commonwealth have
- 11 reasonable access to a center.
- 12 (b) Services.--Each veterans business center established
- 13 under this section shall, at a minimum, provide the following
- 14 services:
- 15 (1) Financial advice, including training and counseling
- on applying for and securing business credit and investment
- 17 capital, preparing and presenting financial statements and
- managing cash flow and other operations of a small business
- 19 concern.
- 20 (2) Information seminars on securing loans, business
- 21 plan development, marketing, accounting, budgeting and
- 22 merchandising.
- 23 (3) Specialized programs to assist veteran-owned small
- businesses to secure capital and repair damaged credit.
- 25 (4) One-on-one counseling to improve financial
- 26 presentation of the businesses to lenders.
- 27 (5) Facilitating the access of veteran-owned businesses
- 28 to both traditional and nontraditional financing sources.
- 29 (6) Counseling to small business owners who are members
- of reserve components to prepare their businesses for periods

- 1 when owners are deployed.
- 2 (7) Programs to assist unemployed veterans to become entrepreneurs.
- 4 (8) Technical assistance with respect to the 5 Commonwealth procurement process.
- 6 (9) Management advice, including training and counseling 7 on the planning, organization, staffing, direction and 8 control of each major activity and function of a small 9 business concern.
- 10 (10) Marketing advice, including training in marketing,
  11 preparing and executing marketing plans, developing pricing
  12 strategies, locating contracting opportunities, negotiating
  13 contracts and using public relations and advertising.
- 14 Section 5. Effective date.
- This act shall take effect in 60 days.
