AN ACT

- Designating a portion of State Route 145 in Salisbury Township, Lehigh County, as the Cpl. Joshua B. Smith Memorial Highway.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Cpl. Joshua B. Smith Memorial Highway.
- 6 (a) Findings.--
- 7 (1) Corporal Joshua B. Smith was born on August 18,
- 8 1985, in Twentynine Palms, California, and a year later
- 9 relocated with his family to the Lehigh Valley area.
- 10 (2) Cpl. Smith lived in Salisbury Township and was a
- 11 2003 graduate of Salisbury High School where he led the
- 12 school's soccer team as captain for two years.
- 13 (3) In 2003, Cpl. Smith joined the Marine Corps and was
- 14 promoted to private first class upon graduation from Parris
- 15 Island, South Carolina.

- 1 (4) After serving eight years in the Marine Corps, Cpl.
- 2 Smith was honorably discharged in 2011.
- 3 (5) Cpl. Smith was awarded the National Defense Service
- 4 Medal, Navy Meritorious Unit Commendation, Global War on
- 5 Terrorism Service Medal, Afghanistan Campaign Medal, Sea
- 6 Service Deployment Ribbon, Marine Corps Good Conduct Medal,
- 7 Korean Defense Service Medal, NATO Article 5 Medal and the
- 8 Navy and Marine Corps Commendation.
- 9 (6) Cpl. Smith returned home and struggled with
- 10 posttraumatic stress disorder and traumatic brain injury
- until he lost his battle on November 5, 2012.
- 12 (b) Designation. -- The section of State Route 145 in
- 13 Salisbury Township, Lehigh County, from Segment 40 Offset 137 to
- 14 Segment 40 Offset 3051 is hereby designated the Cpl. Joshua B.
- 15 Smith Memorial Highway.
- 16 (c) Signs. -- The Department of Transportation shall erect and
- 17 maintain appropriate signs displaying the name of the highway to
- 18 traffic in both directions on the highway.
- 19 Section 2. Effective date.
- 20 This act shall take effect in 60 days.
