- 6 Commonwealth; and
- 7 WHEREAS, Personal financial practices and habits are formed
- 8 during our childhood years; and
- 9 WHEREAS, Many young people establish bad financial management
- 10 habits and stumble financially, learning by trial and error; and
- 11 WHEREAS, Increasing the financial literacy of all economic
- 12 and ethnic groups has proven successful in improving attitudes,
- 13 leading to improved decision making and providing a more secure
- 14 future for individuals who have been educated in financial

- 2 WHEREAS, Financial literacy training may easily be integrated
- 3 as a valuable component for elementary and secondary schools,
- 4 colleges and universities, community groups and resident town
- 5 hall meetings; and
- 6 WHEREAS, This endeavor is worthy of support and cooperation
