A RESOLUTION

- 1 Urging Amtrak to redesignate the railroad station located at
- 2 2955 Market Street in Philadelphia, Pennsylvania, as the
- "William H. Gray III 30th Street Station."
- WHEREAS, From 1979 until 1991, William H. Gray III
- 5 represented Pennsylvania's second congressional district in the
- 6 United States House of Representatives; and
- 7 WHEREAS, For the final two years of his career in the
- 8 Congress of the United States, Mr. Gray served as the Majority
- 9 Whip; and
- 10 WHEREAS, Mr. Gray was the highest-ranking African-American
- 11 member of Congress, attaining distinction as the first African
- 12 American to rise to the third-ranking House position and to
- 13 chair the House Budget Committee; and
- 14 WHEREAS, In 1991, Mr. Gray resigned from Congress to become
- 15 the president and chief executive officer of the United Negro
- 16 College Fund; and
- 17 WHEREAS, Mr. Gray served the United Negro College Fund
- 18 through 2004, raising more than \$2.3 billion during his tenure;

- WHEREAS, Mr. Gray died on July 1, 2013, at 71 years of age;
- 3 and
- 4 WHEREAS, In the summer of 2014, Congress passed and the
- 5 President of the United States signed H.R. 4838, redesignating
- 6 the railroad station located at 2955 Market Street in
- 7 Philadelphia, Pennsylvania, commonly known as "30th Street
- 8 Station," as the "William H. Gray III 30th Street Station"; and
- 9 WHEREAS, Despite this redesignation under Public Law 113-158,
- 10 enacted more than two years ago, Amtrak has not officially
- 11 redesignated the station; therefore be it
- 12 RESOLVED, That the House of Representatives of the
- 13 Commonwealth of Pennsylvania urge Amtrak to redesignate the
- 14 railroad station located at 2955 Market Street in Philadelphia,
- 15 Pennsylvania, as the "William H. Gray III 30th Street Station";
- 16 and be it further
- 17 RESOLVED, That a copy of this resolution be transmitted to
