AN ACT

- 1 Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and
- Judicial Procedure) of the Pennsylvania Consolidated
- 3 Statutes, in assault, further providing for the offense of
- 4 ethnic intimidation; and making an editorial change.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The heading of section 2710 and subsections (a)
- 8 and (c) of Title 18 of the Pennsylvania Consolidated Statutes
- 9 are amended to read:
- 10 § 2710. [Ethnic] Unlawful intimidation.
- 11 (a) Offense defined. -- A person commits the offense of
- 12 [ethnic] unlawful intimidation if, with malicious intention
- 13 toward the <u>actual or perceived</u> race, color, religion [or],
- 14 national origin, ancestry, mental or physical disability, sexual
- 15 <u>orientation, gender or gender identity</u> of another individual or
- 16 group of individuals, he commits an offense under any other
- 17 provision of this article or under Chapter 33 (relating to
- 18 arson, criminal mischief and other property destruction)

- 1 exclusive of section 3307 (relating to institutional vandalism)
- 2 or under section 3503 (relating to criminal trespass) with
- 3 respect to such individual or his or her property or with
- 4 respect to one or more members of such group or to their
- 5 property.
- 6 * * *
- 7 (c) Definition.--As used in this section "malicious
- 8 intention" means the intention to commit any act, the commission
- 9 of which is a necessary element of any offense referred to in
- 10 subsection (a) motivated by hatred toward the actual or
- 11 perceived race, color, religion [or], national origin, ancestry,
- 12 mental or physical disability, sexual orientation, gender or
- 13 gender identity of another individual or group of individuals.
- 14 Section 2. Section 8309(a) of Title 42 is amended to read:
- 15 § 8309. Civil rights violations.
- 16 (a) Redress for personal injury. -- A person who incurs injury
- 17 to his person or damage or loss to his property as a result of
- 18 conduct described in 18 Pa.C.S. § 2710 (relating to [ethnic]
- 19 <u>unlawful</u> intimidation) or 3307 (relating to institutional
- 20 vandalism) shall have a right of action against the actor for
- 21 injunction, damages or other appropriate civil or equitable
- 22 relief. In the action, the issue of whether the defendant
- 23 engaged in the conduct alleged shall be determined according to
- 24 the burden of proof used in other civil actions for similar
- 25 relief. The plaintiff may seek recovery for any of the
- 26 following:
- 27 (1) General and special damages, including damages for
- emotional distress. Damages under this paragraph shall be
- actual damages or \$500, whichever is greater.
- 30 (2) Punitive damages.

- 1 (3) Reasonable attorney fees and costs.
- 2 (4) Injunctive and other equitable relief.
- 3 (5) Such other relief which the court deems necessary
- 4 and proper.

- 6 Section 3. This act shall take effect in 60 days.
