AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in duties and powers of boards of 5 school directors, further providing for additional schools 6 and departments and for kindergartens; and, in terms and 7 courses of study, further providing for dates and times of 8 school terms and sessions. The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 12 Section 1. Section 502 of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, amended May 9, 13 14 1949 (P.L.939, No.263), is amended to read: 15 Section 502. Additional Schools and Departments. -- In addition to the elementary public schools, the board of school 16 17 directors in any school district may establish, equip, furnish, 18 and maintain the following additional schools or departments for 19 the education and recreation of persons residing in said 20 district, and for the proper operation of its schools, namely: --

- 1 Trade schools,
- 2 Vocational schools,
- 3 Technical schools,
- 4 Cafeterias,
- 5 Agricultural schools,
- 6 Evening schools,
- 7 [Kindergartens,]
- 8 Libraries,
- 9 Museums,
- 10 Reading-rooms,
- 11 Gymnasiums,
- 12 Playgrounds,
- 13 Schools for physically and mentally handicapped,
- 14 Truant schools,
- 15 Parental schools,
- 16 Schools for adults,
- 17 Public lectures,
- 18 Such other schools or educational departments as the
- 19 directors, in their wisdom, may see proper to establish.
- 20 Said additional schools or departments, when established,
- 21 shall be an integral part of the public school system in such
- 22 school district and shall be so administered.
- No pupil shall be refused admission to the courses in these
- 24 additional schools or departments, by reason of the fact that
- 25 his elementary or academic education is being or has been
- 26 received in a school other than a public school.
- 27 Section 2. Section 503 of the act, amended September 21,
- 28 1959 (P.L.925, No.373) and October 21, 1965 (P.L.601, No.312),
- 29 is amended to read:
- 30 Section 503. Kindergartens.--(a) The board of school

- 1 directors in [any] every school district [may] shall establish
- 2 and maintain kindergartens for children between the ages of four
- 3 and six years. [When established, the] The kindergartens shall
- 4 be an integral part of the elementary school system of the
- 5 district, and be kept open for not less than [two and one-half]
- 6 <u>five</u> hours each day for the full school term as provided in
- 7 section 1501.
- 8 (b) The number of kindergartens in any one district shall be
- 9 fixed by the board of school directors, and shall be open during
- 10 the school year. <u>Kindergartens shall be made available to all</u>
- 11 children in residence within the school district who are between
- 12 the ages of four and six years.
- 13 [If the average attendance in any one kindergarten in any
- 14 district is ten or less for the school year, the school
- 15 directors shall, at the close of the school year, discontinue
- 16 the same.]
- 17 <u>(c)</u> The board of school directors shall appoint and assign a
- 18 sufficient number of teachers to such kindergartens, who shall
- 19 be certified in accordance with the rules and regulations
- 20 prescribed by the [Council of Basic Education] State Board of
- 21 Education.
- Section 3. Section 1504(a) of the act, amended July 1, 1978
- 23 (P.L.575, No.105), is amended to read:
- 24 Section 1504. Dates and Times of School Terms and Sessions;
- 25 Commencement. -- (a) The board of school directors of each school
- 26 district shall fix the date of the beginning of the school term.
- 27 Unless otherwise determined by the board, the daily session of
- 28 school shall open at nine ante-meridian and close at four post-
- 29 meridian, with an intermission of one hour at noon, and an
- 30 intermission of fifteen minutes in the forenoon and in the

- 1 afternoon. Upon request of a board of school directors for an
- 2 exception to the aforesaid daily schedule, the Secretary of
- 3 Education may, when in his opinion a meritorious educational
- 4 program warrants, approve a school week containing a minimum of
- 5 twenty seven and one-half hours of instruction as the equivalent
- 6 of five (5) school days, or a school year containing a minimum
- 7 of nine hundred ninety hours (990) of instruction at the
- 8 secondary level or nine hundred (900) hours of instruction at
- 9 the elementary level or nine hundred (900) hours of instruction
- 10 <u>at the kindergarten level</u> as the equivalent of one hundred
- 11 eighty (180) school days. Professional and temporary
- 12 professional employes shall be allowed a lunch period free of
- 13 supervisory or other duties of at least thirty minutes. The
- 14 provisions of this subsection shall not be construed to repeal
- 15 any rule or regulation of any board of school directors now in
- 16 effect which provides for a lunch period longer than the minimum
- 17 prescribed herein or to repeal any action of any board of school
- 18 directors taken in compliance with section 7 of the act of July
- 19 25, 1913 (P.L.1024, No.466), entitled "An act to protect the
- 20 public health and welfare, by regulating the employment of
- 21 females in certain establishments, with respect to their hours
- 22 of labor and the conditions of their employment; by establishing
- 23 certain sanitary regulations in the establishments in which they
- 24 work; by requiring certain abstracts and notices to be posted;
- 25 by providing for the enforcement of this act by the Commissioner
- 26 of Labor and Industry and others; by prescribing penalties for
- 27 violations thereof; by defining the procedure in prosecutions;
- 28 and by repealing all acts and parts of acts inconsistent with
- 29 the provisions thereof," as amended.

- 1 Section 4. This act shall apply to the 2016-2017 school year
- 2 and each school year thereafter.
- 3 Section 5. This act shall take effect immediately.
