6	§ 5330.1. Consideration of other conduct and child conceived as
7	<u>a result of certain conduct.</u>
8	No court shall award custody, partial custody or supervised
9	physical custody to a parent where the court finds by clear and
10	convincing evidence both of the following:
11	(1) The child for whom custody, partial custody or
12	supervised physical custody is sought was conceived as a
13	result of conduct that would constitute an offense under one
14	or more of the following criminal statutes:
15	(i) Rape under 18 Pa.C.S. § 3121 (relating to rape).
16	<u>(ii) Statutory sexual assault under 18 Pa.C.S. §</u>
17	3122.1 (relating to statutory sexual assault).
